

1-21-14 City of Long Beach Counsel Meeting

- On 3-10-10 W A Rasic, a contractor working on the Termino Drain Project, was allowed to use Parcel M located at 2206 Cover St. just north of the Long Beach Airport and East of Cherry Avenue. (Show before pictures)
- Parcel M was to be used to process material from the Termino Drain Project only.
- In lieu rent, the contractor was to clean up and grade the site.
- On 6-7-10 the contractor started advertising Parcel M as a dump site accepting materials from the general public, in violation of their agreement.
- In June of 2010 Brett Bush, of code enforcement was notified about this unlicensed operation being in violation of the zoning regulation and not having a Conditional Uses Permit or a Business License.
- On 5-9-12, after nearly two years of inaction, the City attorney Richard Anthony finally sent the contractor a Cease and Desist letter.
- On 6-11-12, after ignoring the Cease and Desist letter of 5-9-12 and continuing to operate, another Cease and Desist letter, terminating the original agreement was sent.
- On 7-11-12 the contractor stopped operating and left the site with thousands of tons of rubble pile up for the city to deal with. (show after pictures)
- The Contractor W A Rasic collected thousands of dollars for dump fees and left the city to pay to clean up the site. The cost is estimated to be in the MILLONS OF DOLLARS.

Questions:

- 1. Why was the contractor allowed to operate an illegal dump site for two years rent free?
- 2. Why is the city not forcing the contractor to clean up and re-grade the site per the agreement?

Illegal Recycling Operations at Long Beach Airport Parcel M

Gentlemen:

As you know, W.A. Rasic Construction Company ("Rasic") is currently operating recycling equipment on certain property located north of the Long Beach Airport commonly known as Parcel M (the "Site"). Rasic is operating at the Site pursuant to a Commercial Use Permit issued by the Director of the Long Beach Airport (the "Permit"). The Permit expressly limits use of the Site by Rasic to recycling in connection with the Termino Drain Project.

We have reason to believe that since December of last year Rasic has sporadically provided recycling services at the Site to members of the public, even after being told by City staff that accepting recycling materials from the public was prohibited.

PLEASE IMMEDIATELY CEASE AND DESIST accepting recycling materials from any party other than the City at the Site. Rasic's operations at the Site are to be limited to recycling in connection with the Termino Drain Project only. Any recycling operation open to the general public at the Site violates the Permit and violates various local Codes. Any further operations conducted by Rasic which violate the Permit and/or applicable City Codes will result in City taking all legal actions available to it, including without limitation revocation of the Permit, imposition of fines, and recovery of potential monetary damages.

This correspondence shall also serve as notice of termination of the Commercial Use Permit by and between the City of Long Beach and Rasic (the "Permit") for the Site, pursuant to Section 2 of the Permit. Rasic must clear all of its personal property from the site by July 11, 2012.
