RECOMMENDATION:

Adopt a Resolution to approve ten repaving/resurfacing projects proposed to receive Road Maintenance and Rehabilitation Account Act funding totaling approximately \$8,000,000 for Fiscal Year 2018-19: 15th Street between Lewis Avenue and Obispo Avenue; Anaheim Street between Pacific Avenue and Atlantic Avenue; Ocean Boulevard between Magnolia Avenue and Long Beach Boulevard; Studebaker Road between Almada Road and Atherton Street; Anaheim Street between Gardena Avenue and Ximeno Avenue; Studebaker Road between Wardlow Road and Walkerton Street; Anaheim Street between Alamitos Avenue and Gardena Avenue; Willow Street between Magnolia Avenue and Earl Avenue; Market Street between Orange Avenue and Cherry Avenue; and, Artesia Boulevard between Schilling Avenue and Paramount Boulevard. (Citywide)

DISCUSSION

City Council approval is requested to adopt a Resolution to approve a list of projects proposed to receive Road Maintenance and Rehabilitation Act (RMRA) funding for Fiscal Year (FY) 2018-19.

Senate Bill 1 (SB 1), the Road Repair and Accountability Act of 2017 (Chapter 5, Statutes of 2017), was passed by the California Legislature and signed into law by the Governor in April 2017, to address significant multi-modal transportation funding shortfalls statewide. Long Beach will receive an estimated \$8 million in RMRA funding for FY 2018-19.

Eligibility requirements under SB 1 require that a list of projects proposed to receive RMRA funding be identified in a Resolution approved by City Council, which must include scope, location, schedule, and useful life information. The bill also requires the use of a pavement management system (PMS) to develop the SB 1 project list to ensure revenues are being used on the most high-priority and cost-effective projects.

This matter was reviewed by Deputy City Attorney Linda T. Vu on April 16, 2018 and by Budget Analysis Officer Julissa José-Murray on April 20, 2018.

TIMING CONSIDERATIONS

City Council action is requested on May 8, 2018, to ensure eligibility to receive RMRA funds in accordance with SB 1.

FISCAL IMPACT

To receive RMRA funds, the City must adopt a Resolution, which lists the projects planned to be funded with RMRA funds in FY 2018-19. SB 1 is estimated to provide the City funds totaling approximately \$8 million in FY 2018-19. The recommended action is for the City Council is to adopt the Resolution, no budget appropriation is requested at this time. When the City receives a formal amount from the California State Controller's Office, an appropriation increase will be requested from the City Council.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH ADOPTING A LIST OF PROJECTS FOR FISCAL YEAR 2018-19 FUNDED BY SB 1: THE ROAD REPAIR AND ACCOUNTABILITY ACT OF 2017

WHEREAS, Senate Bill 1 ("SB 1"), the Road Repair and Accountability Act of 2017 (Chapter 5, Statutes of 2017) was passed by the Legislature and signed into law by the Governor in April 2017 in order to address the significant multi-modal transportation funding shortfalls statewide; and

WHEREAS, SB 1 includes accountability and transparency provisions that will ensure the residents of the City of Long Beach, California ("City") are aware of the projects proposed for funding in our community and which projects have been completed each fiscal year; and

WHEREAS, the City must adopt a list of all projects proposed to receive funding from the Road Maintenance and Rehabilitation Account ("RMRA"), created by SB 1 by resolution, which must include a description and the location of each proposed project, a proposed schedule for the project's completion, and the estimated useful life of the improvement; and

WHEREAS, the City will receive an estimated Eight Million Dollars (\$8,000,000) in RMRA funding in fiscal year 2018-19 from SB 1; and

WHEREAS, this is the second year in which the City is receiving SB 1 funding and will enable the City to continue essential road maintenance and rehabilitation projects, safety improvements, and increasing access and mobility options for the traveling public that would not have otherwise been possible without SB 1; and

WHEREAS, the City has undergone a robust public process to ensure public input into our community's transportation priorities/the project list; and

WHEREAS, the funding from SB 1 will help the City maintain and rehabilitate many streets/roads, and add active transportation infrastructure throughout the City this year and similar projects into the future; and

WHEREAS, the 2016 California Statewide Local Streets and Roads Needs
Assessment found that the City's streets and roads are in a "fair" condition and this
revenue will help us maintain the "fair" condition; and

WHEREAS, the SB 1 project list and overall investment in our local streets and roads infrastructure with a focus on basic maintenance and safety, investing in complete streets infrastructure, and using cutting-edge technology, materials and practices, will have significant positive co-benefits statewide;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. The foregoing recitals are true and correct.

Section 2. The fiscal year 2018-19 list of projects planned to be funded with Road Maintenance and Rehabilitation Account revenues include the following:
