3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH AUTHORIZING THE CITY
5 MANAGER TO PURCHASE CUSTODIAL PAPER
6 PRODUCTS AND JANITORIAL CLEANING SUPPLIES
7 FROM FASTENAL COMPANY ON THE SAME TERMS
8 AND CONDITIONS AS THE AGREEMENT UNDER THE
9 WESTERN STATES CONTRACTING ALLIANCE (WSCA)
10 MASTER SERVICE AGREEMENT ACTING BY AND
11 THROUGH THE STATE OF NEVADA

13 WHEREAS, the Charter of the City of Long Beach (the "City"), Section
14 1802, permits the City to purchase services, supplies, materials, equipment and labor
15 with other government agencies by purchasing under their contracts on a voluntary and
16 selective basis when authorized by resolution; and

17 WHEREAS, the City desires to purchase custodial paper products and
18 janitorial cleaning supplies; and

19 WHEREAS, Western States Contracting Alliance (WSCA) Master Service
20 Agreement Contract No. 7-11-51-01, acting by and through the State of Nevada, has a
21 contract with Fastenal Company, Contract No. 1862 (Nevada Contract); and

22 WHEREAS, City's participation in the Nevada Contract will facilitate
23 acquisition of the custodial paper products and janitorial cleaning supplies as well as
24 provide considerable cost benefits to the City; and

25 WHEREAS, if the City had to go to formal bid rather than participate in the
26 Nevada Contract considerably more funds would be required;

27 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
28 follows:

1 Section 1. The above recitals are true and correct and are incorporated
2 herein by this reference.

3 Section 2. The City Manager is hereby authorized to enter into an
4 agreement with Fastenal Company for the purchase of custodial paper products and
5 janitorial cleaning supplies on the same terms and conditions as those under Western
6 States Contracting Alliance (WSCA) Master Service Agreement Contract No. 7-11-51-01,
7 acting by and through the State of Nevada, Contract No. 1862, in a total amount not to
8 exceed \$720,000, including taxes and fees, for a period of one year, with the option to
9 extend the contract for two one-year periods.

10 Section 3. This resolution shall take effect immediately upon its adoption
11 by the City Council, and the City Clerk shall certify to the vote adopting this resolution.

12 I hereby certify that the foregoing resolution was adopted by the City
13 Council of the City of Long Beach at its meeting of April 3, 2012 by the
