3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH APPROVING THE APPLICATION
5 FOR OUTDOOR ENVIRONMENTAL EDUCATION
6 FACILITIES GRANT FUNDS

8 WHEREAS, the State Department of Parks and Recreation has been
9 delegated the responsibility by the Legislature of the State of California for the
10 administration of the Outdoor Environmental Education Facilities Grant Program, setting
11 up necessary procedures governing the application; and

12 WHEREAS, said procedures established by the State Department of Parks
13 and Recreation require the applicant to certify by resolution the approval of the
14 application before submission of said application to the State; and

15 WHEREAS, successful applicants will enter into a contract with the State of
16 California to complete the grant scope of work;

17 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
18 follows:

19 Section 1. The City Council approves the filing of an application by the
20 City of Long Beach ("Applicant") for the Willow Springs Outdoor Education Trailhead and
21 Trail Network ("Project").

22 Section 2. The City Council certifies that said Applicant has or will have
23 available, prior to commencement of any work on the Project included in the application,
24 the sufficient funds to complete the Project.

25 Section 3. The City Council certifies that if the Project is awarded, the
26 Applicant has or will have sufficient funds to operate and maintain the Project.

27 Section 4. The City Council certifies that the Applicant has reviewed,
28 understands, and agrees to the general provisions contained in the contract shown in the

2 Section 5. The City Council delegates the authority to the City Manager,
3 or designee, to conduct all negotiations, sign and submit all documents, including, but not
4 limited to applications, agreements, amendments, and payment requests, which may be
5 necessary for the completion of the grant scope of work.

6 Section 6. The City Council agrees to comply with all applicable federal,
7 state and local laws, ordinances, rules, regulations and guidelines.

8 Section 7. This resolution shall take effect immediately upon its adoption
9 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
