In light of the location of this restaurant with residential above, I request Council concurrence and ABC approval of the following conditions:

1) The Quarterly gross sales of alcoholic beverages shall not exceed the gross sales of food during the same period. The licensee shall at all times maintain records which reflect separately the gross sales of food and the gross sales of alcoholic beverages of the licensed business. Said records shall be kept no less frequently than on a quarterly basis and shall be made available to the Department on demand.

2) Trash shall not be emptied between the hours of 10:00 pm and 7:00 am.

3) The petitioner shall be responsible for maintaining free of litter the area adjacent to the premises over which they have control.
