RESOLUTION NO. RES-18-0150

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH ZOLL MEDICAL CORPORATION, WITHOUT ADVERTISING FOR BIDS, FOR THE PURCHASE OF 12-LEAD ELECTROCARDIOGRAM UNITS, AUTOMATED EXTERNAL DEFIBRILLATORS, AND RELATED EQUIPMENT, SUPPLIES, AND REPAIR SERVICES, IN AN ANNUAL AMOUNT NOT TO EXCEED \$330,000

WHEREAS, the Long Beach Fire Department currently utilizes 12-lead electrocardiogram units, automated external defibrillators, and related equipment, supplies, and repair services supplied by Zoll Medical Corporation to provide emergency medical services; and

WHEREAS, the Long Beach Fire Department requires additional units, parts and accessories compatible with its current equipment, on which emergency response personnel have been trained; and

WHEREAS, Zoll Medical Corporation does not use regional distributors and is the sole manufacturer and source for its products; and

WHEREAS, as a result, no useful purpose would be served by advertising for bids for 12-lead electrocardiogram units, automated external defibrillators, and related equipment, supplies, and repair services, and to do so would constitute an idle and useless act and an unnecessary expenditure of public funds;

1 NOW, THEREFORE, the City Council of the City of Long Beach resolves as  
2 follows:

3 Section 1. The City Manager is hereby authorized to enter a contract,  
4 without advertising for bids, with Zoll Medical Corporation for the purchase of 12-lead  
5 electrocardiogram units, automated external defibrillators, and related equipment,  
6 supplies, and repair services for a period of two (2) years in an amount not to exceed  
7 Three Hundred Thousand Dollars (\$300,000) annually, and a 10 percent contingency in  
8 the amount of Thirty Thousand Dollars (\$30,000), for a total annual amount not to exceed  
9 Three Hundred Thirty Thousand Dollars (\$330,000), with the option of renewing the  
10 agreement for three (3) additional one-year periods at the discretion of the City Manager  
11 or his or her designee. If the sole source status of Zoll Medical Corporation changes, the  
12 City shall publicly bid instead of extending the contract.

13 Section 2. This resolution shall take effect immediately upon its adoption  
14 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
