

1 FIRST AMENDMENT TO AGREEMENT NO. 32315

3 THIS FIRST AMENDMENT is made and entered, in duplicate, as of August  
4 30, 2012, pursuant to a minute order adopted by the City Council of the City of Long  
5 Beach at its meeting on June 21, 2011 by and between SOLNOVO, INC., a California  
6 corporation, with a place of business at 2828 Cochran Street, # 256, Simi Valley, CA  
7 93065 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

8 WHEREAS, the parties executed Agreement No. 32315 for a term of one  
9 (1) year in 2011 with options to renew the term for additional years; and

10 WHEREAS, the parties desire to exercise the first option to extend the term  
11 for an additional one (1) year:

12 1. Section 2 of Agreement No. 32315 is hereby amended in it entirety  
13 to read as follows:

14 " 2. TERM. The term of this Agreement shall commence on September  
15 1, 2011, and shall terminate on August 31, 2013, unless terminated earlier, as  
16 provided in this Agreement. City's City Manager shall have one (1), one-year  
17 option to renew the Agreement."

18 2. Except as expressly stated herein, all of the terms, covenants, and  
19 conditions of Lease No. 32315 are ratified and confirmed and shall remain in full force  
20 and effect.
