## **RESOLUTION NO. C-**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH CERTIFYING THE RESULTS OF THE CONSOLIDATED PRIMARY NOMINATING ELECTION HELD IN THE CITY OF LONG BEACH, CALIFORNIA, ON TUESDAY, APRIL 13, 2004, FOR THE PURPOSE OF NOMINATING AND/OR ELECTING CANDIDATES FOR ONE (1) OFFICE ON THE GOVERNING BOARD OF THE LONG BEACH UNIFIED SCHOOL DISTRICT, AND FOR ONE (1) OFFICE ON THE BOARD OF TRUSTEES OF THE LONG BEACH COMMUNITY COLLEGE DISTRICT

WHEREAS, the City Council of the City of Long Beach did, by Resolution No. C-28291, duly call and provide for the holding of a Primary Nominating Election on Tuesday, April 13, 2004, for the purpose of nominating and/or electing candidates for the office of four (4) offices on the City Council namely, for the Second, Fourth, Sixth and Eighth Districts; and

WHEREAS, on November 18, 2003, the City Council adopted Resolution No. C-28292 consenting to the requests of the Board of Education of the Long Beach Unified School District and the Board of Trustees of the Long Beach Community College District to consolidate the Governing Board Member elections for said Districts pursuant to the provisions of Section 10400 of the California Elections Code with the City's Primary Nominating Election for the purpose of nominating and/or electing candidates for one (1) office on the Governing Board of the Long Beach Unified School District, each for a full term of four (4) years, commencing on the third Monday of July, 2000, and for one (1) office on the Board of Trustees of the Long Beach Community College District, for a full term of four (4) years, commencing with the first day of the

WHEREAS, the consolidated election was held in the City of Long Beach on April 13, 2004; and

WHEREAS, the City Clerk, pursuant to Long Beach Municipal Code Section 1.21.010, adopted by the City Council on January 2, 1996, duly canvassed the returns of the election, including the absentee ballots issued in connection with the election which were returned as required by law;

NOW, THEREFORE, the City Council of the City of Long Beach does resolve, determine, order and declare as follows:

Section 1. That the absent voter ballots issued in connection with the election which have been returned as required by law have been duly canvassed, and the results of that count have been recorded. That the City Clerk has duly canvassed the returns of the election held on April 13, 2004 for Member of the Board of Education of the Long Beach Unified School District and for Members of the Long Beach Community College District, and has filed a Certificate of Canvass with the City Council and from that certification the City Council finds that the total number of votes cast in each district, the total number of votes cast in each of the respective election precincts established for the election, the number of votes cast for each candidate in each precinct and the total number of votes for each candidate are as provided in Exhibit "A" attached to and made a part of this resolution.

Sec. 2. That the candidates nominated as required by law for the one (1) office of Member of the Board of Trustees of the Long Beach Community College District were:

Trustee Area 4 - Richard F. Gaylord Douglas W. Otto

Sec. 3. That said candidates for the office of Member of the Board of Trustees of the Long Beach Community College District received the number of votes indicated in Exhibit "A" from those precincts listed on said Exhibit "A".
