3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH CERTIFYING THE RESULTS OF
5 THE CONSOLIDATED PRIMARY NOMINATING ELECTION
6 HELD IN THE CITY OF LONG BEACH, CALIFORNIA, ON
7 TUESDAY, APRIL 13, 2004, FOR THE PURPOSE OF
8 NOMINATING AND/OR ELECTING CANDIDATES FOR ONE
9 (1) OFFICE ON THE GOVERNING BOARD OF THE LONG
10 BEACH UNIFIED SCHOOL DISTRICT, AND FOR ONE (1)
11 OFFICE ON THE BOARD OF TRUSTEES OF THE LONG
12 BEACH COMMUNITY COLLEGE DISTRICT

14 WHEREAS, the City Council of the City of Long Beach did, by Resolution
15 No. C-28291, duly call and provide for the holding of a Primary Nominating Election on
16 Tuesday, April 13, 2004, for the purpose of nominating and/or electing candidates for
17 the office of four (4) offices on the City Council namely, for the Second, Fourth, Sixth
18 and Eighth Districts; and

19 WHEREAS, on November 18, 2003, the City Council adopted Resolution
20 No. C-28292 consenting to the requests of the Board of Education of the Long Beach
21 Unified School District and the Board of Trustees of the Long Beach Community
22 College District to consolidate the Governing Board Member elections for said Districts
23 pursuant to the provisions of Section 10400 of the California Elections Code with the
24 City's Primary Nominating Election for the purpose of nominating and/or electing
25 candidates for one (1) office on the Governing Board of the Long Beach Unified School
26 District, each for a full term of four (4) years, commencing on the third Monday of July,
27 2000, and for one (1) office on the Board of Trustees of the Long Beach Community
28 College District, for a full term of four (4) years, commencing with the first day of the

1 calendar month next succeeding his or her election; and

2 WHEREAS, the consolidated election was held in the City of Long Beach
3 on April 13, 2004; and

4 WHEREAS, the City Clerk, pursuant to Long Beach Municipal Code
5 Section 1.21.010, adopted by the City Council on January 2, 1996, duly canvassed the
6 returns of the election, including the absentee ballots issued in connection with the
7 election which were returned as required by law;

8 NOW, THEREFORE, the City Council of the City of Long Beach does
9 resolve, determine, order and declare as follows:

10 Section 1. That the absent voter ballots issued in connection with the
11 election which have been returned as required by law have been duly canvassed, and
12 the results of that count have been recorded. That the City Clerk has duly canvassed
13 the returns of the election held on April 13, 2004 for Member of the Board of Education
14 of the Long Beach Unified School District and for Members of the Long Beach
15 Community College District, and has filed a Certificate of Canvass with the City Council
16 and from that certification the City Council finds that the total number of votes cast in
17 each district, the total number of votes cast in each of the respective election precincts
18 established for the election, the number of votes cast for each candidate in each
19 precinct and the total number of votes for each candidate are as provided in Exhibit "A"
20 attached to and made a part of this resolution.

21 Sec. 2. That the candidates nominated as required by law for the
22 one (1) office of Member of the Board of Trustees of the Long Beach Community
23 College District were:

24 Trustee Area 4 - Richard F. Gaylord
25 Douglas W. Otto

26 Sec. 3. That said candidates for the office of Member of the Board
27 of Trustees of the Long Beach Community College District received the number of
28 votes indicated in Exhibit "A" from those precincts listed on said Exhibit "A".
