"Dock 10" means that three<u>five</u> hundred<u>twelve</u> foot (<u>300512'</u>) dock located at a point approximately one hundred twenty-three feet (123') west of the building known as 160 East Shoreline Drive and running in a westerly direction for one hundred <u>fiftysixty-one</u> feet (<u>15061'</u>) and southerly for <u>onethree</u> hundred fifty<u>-one</u> feet (<u>150351'</u>).

16.08.910 - Waiting list administration fee.

In addition to any payment or deposit required by Section 16.08.900, any person who submits an application for a slip within the marinas, which application is filed in the separate waiting list of pending applications for slips, shall pay a one (1) time waiting list administration fee in the amount prescribed in regulations enacted pursuant to Section 16.08.970.

ORDINANCE NO.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AMENDING THE LONG BEACH MUNICIPAL CODE BY AMENDING SECTION 16.08.266; AND BY REPEALING SECTION 16.08.910, ALL RELATING TO MARINAS

WHEREAS, in 2014, Dock 10 at 435 Shoreline was replaced with a new 512 foot concrete dock that increased the existing Dock 10 size and dimensions, requiring an amendment to the Long Beach Municipal Code Section 16.08.266 to reflect the new dimensions; and

WHEREAS, the City Council maintains and adopts a Master Fee and Charges Schedule Resolution during the annual budget process. A fee for administration of a waiting list for boat slips is included in the Resolution and the City Council finds Long Beach Municipal Section 16.08.910 "Waiting List Administration Fee" is duplicative of the Annual Fee Resolution and should be repealed;

NOW, THEREFORE, the City Council of the City of Long Beach ordains as follows:

Section 1. Section 16.08.266 of the Long Beach Municipal Code is amended to read as follows:

16.08.266 Dock 10.

"Dock 10" means that five hundred twelve foot (512') dock located at a point approximately one hundred twenty-three feet (123') west of the building known as 160 East Shoreline Drive and running in a westerly direction for one hundred sixty-one feet (161') and southerly for three hundred fifty-one feet (351').
