

1 THIRD AMENDMENT TO AGREEMENT NO. 35554

3 THIS THIRD AMENDMENT TO AGREEMENT NO. 35554 is made and
4 entered, in duplicate, as of March 2, 2023, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on June
6 9, 2020, by and between SWS2, INC. DBA THE RYTE PROFESSIONALS, a California
7 corporation ("Consultant"), whose address is 4699 Montefino Drive, Cypress, California
8 90630, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
10 35554 (the "Agreement") whereby Consultant agreed to provide as-needed professional
11 and technical services for system analysis, development, implementation, project
12 management, and technical support for information technology projects and systems; and

13 WHEREAS, the Parties entered into a First Amendment to extend the term
14 one (1) additional one-year period; and

15 WHEREAS, the Parties entered into a Second Amendment to increase the
16 annual contract amount to \$2,500,000; and

17 WHEREAS, the Parties desire to increase the annual contract amount to
18 \$3,000,000;

19 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
20 conditions herein contained, the Parties agree as follows:

21 1. Section 1.A. of the Agreement is hereby amended to read as follows:

22 "A. Consultant shall furnish specialized services more particularly
23 described in Exhibit "A", attached to this Agreement and incorporated by this reference, in
24 accordance with the standards of the profession, and City shall pay for these services in
25 the manner described below, in an amount not to exceed Three Million Dollars
26 (\$3,000,000) annually, at the rates or charges shown in Exhibit "B"."

27 2. Except as expressly modified herein, all of the terms and conditions
28 contained in Agreement No. 35554 are ratified and confirmed and shall remain in full force
