THIS FIFTH AMENDMENT TO AGREEMENT NO. 31919 is made and entered, in duplicate, as of December 18, 2015 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on December 15, 2015, by and between AECOM TECHNICAL SERVICES, INC., a California corporation, with a place of business at 999 Town and Country Road, Orange, California 92868 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the City requires specialized services requiring unique skills to be performed in connection with As-Needed Engineering Consulting Services; and

WHEREAS, the parties entered Agreement No. 31919 whereby Consultant agreed to provide As-Needed Engineering Consulting Services; and

WHEREAS, the parties desire to extend the term;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the parties agree as follows:

1. Section 2 of Agreement No. 31919 is hereby amended to read as follows:

"2. TERM. The term of this Agreement shall commence at midnight on September 15, 2010, and shall terminate at 11:59 p.m. on December 30, 2016, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 31919 are ratified and confirmed and shall remain in full force and effect.
