SIXTH AMENDMENT TO AGREEMENT NO. 33203

3 THIS SIXTH AMENDMENT TO AGREEMENT NO. 33203 is made and  
4 entered, in duplicate, as of October 25, 2022, for reference purposes only, pursuant to a  
5 minute order adopted by the City Council of the City of Long Beach at its meeting on  
6 October 18, 2022 by and between KPMG LLP, a Delaware limited liability partnership  
7 ("Consultant"), with a place of business at 20 Pacifica, Suite 700, Irvine, CA 92618-3391,  
8 and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.  
10 33203 (the "Agreement") whereby Consultant agreed to provide annual financial audits,  
11 including the audit of the Comprehensive Annual Financial Report ("CAFR"); and

12 WHEREAS, the Parties entered into a First Amendment to the Agreement to  
13 amend the payment of various programs and extend the term to June 30, 2016; and

14 WHEREAS, the Parties entered into a Second Amendment to the Agreement  
15 to amend the payment of various programs and extend the term to June 30, 2017; and

16 WHEREAS, the Parties entered into a Third Amendment to the Agreement  
17 to amend the payment of various programs, extend the term to June 30, 2018, and attach  
18 a revised rate sheet; and

19 WHEREAS, the Parties entered into a Fourth Amendment to the Agreement  
20 to extend the term to June 30, 2021 and attach a revised rate sheet; and

21 WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to  
22 add the authorized annual amount of \$922,895 for a total not to exceed amount of  
23 \$8,200,476 and extend the term to June 30, 2022; and

24 WHEREAS, the Parties desire to increase the authorized expenditure  
25 amount under the Agreement by \$931,000 instead of basing it on the CPI adjustment noted  
26 in Section 2.C.i. of the Agreement for a total not to exceed amount of \$9,131,476, and  
27 extend the term one (1) additional one-year period;

28 NOW, THEREFORE, in consideration of the mutual terms, covenants, and

1 conditions herein contained, the Parties agree as follows:

2           1.       Section 2 of the Agreement is amended so that, notwithstanding any  
3 other provision of the Agreement to the contrary, City shall pay Consultant a sum not to  
4 exceed Nine Hundred Thirty-One Thousand Dollars (\$931,000) for services provided  
5 between and including July 1, 2022 through June 30, 2023. Such payment shall otherwise  
6 be made in accordance with Section 2 of the Agreement.

7           2.       Section 3 of the Agreement is hereby amended to read as follows:

8           "3.       TERM. The term of this Agreement shall commence at midnight on  
9 July 1, 2013, and shall terminate at 11:59 p.m. on June 30, 2023, unless sooner terminated  
10 as provided in this Agreement, or unless the services or the Project is completed sooner."

11           3.       Except as expressly amended in this Amendment, all terms and  
12 conditions in Agreement No. 33203 are ratified and confirmed and shall remain in full force  
13 and effect.
