THIS TENTH AMENDMENT TO AGREEMENT NO. 33392 is made and entered, in duplicate, as of April 12, 2019, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on December 18, 2018, by and between THE RYTE PROFESSIONALS, a corporation ("Consultant"), with a place of business at 4141 Ball Road, #517, Cypress, California 90630, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the City requires specialized services requiring unique skills to be performed on an as-needed basis in connection with professional and technical services for information technology projects and systems; and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 33392 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to increase the not to exceed amount to \$100,000; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to increase the not to exceed amount to \$200,000; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to increase the not to exceed amount to \$400,000 and extend the term to January 22, 2017; and

WHEREAS, the Parties entered into a Fourth Amendment to the Agreement to increase the not to exceed amount to \$600,000; and

WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to increase the not to exceed amount to \$900,000; and

WHEREAS, the Parties entered into a Sixth Amendment to the Agreement to increase the total not to exceed amount to \$1,500,000 and extend the term to January 22, 2018; and

WHEREAS, the Parties entered into a Seventh Amendment to the

1 Agreement to increase the total not to exceed amount to \$2,000,000; and

2 WHEREAS, the Parties entered into an Eight Amendment to the Agreement  
3 to increase the total not to exceed amount to \$3,000,000 and extend the term to January  
4 22, 2019; and

5 WHEREAS, the Parties entered into a Ninth Amendment to the Agreement  
6 to increase the total not to exceed amount to \$3,350,000 and extend the term to May 22,  
7 2019; and

8 WHEREAS, the Parties desire to add \$1,150,000 to the Agreement for a total  
9 not to exceed amount of \$4,500,000;

10 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
11 conditions herein contained, the Parties agree as follows:

12 1. Section 1.A of the Agreement is hereby amended to read as follows:

13 "A. Consultant shall furnish specialized services more particularly  
14 described in Exhibit "A," attached to the Agreement and incorporated by this  
15 reference, in accordance with the standards of the profession, and City shall pay  
16 for these services in the manner described below, a total not to exceed contract  
17 amount of Four Million Five Hundred Thousand Dollars (\$4,500,000), at the rates  
18 or charges shown in Exhibit "A".

19 2. Except as expressly modified herein, all of the terms and conditions  
20 contained in Agreement No. 33392 are ratified and confirmed and shall remain in full force  
21 and effect.
