A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER TO PURCHASE 41 TECHNICIAN WORK STATIONS FOR USE BY FLEET SERVICES BUREAU THROUGH THE AGREEMENT BETWEEN CORONA-NORCO UNIFIED SCHOOL DISTRICT AND SNAP-ON INDUSTRIAL, A DIVISION OF IDSC HOLDINGS LLC.

WHEREAS, the Charter of the City of Long Beach (the "City"), Section 1802, permits the City to purchase services, supplies, materials, equipment and labor with other government agencies by purchasing under their contracts on a voluntary and selective basis when authorized by resolution; and

WHEREAS, the City desires to purchase 41 technician work stations for use by Fleet Services Bureau Maintenance staff ("Work Stations"); and

WHEREAS, the Corona-Norco Unified School District has an Agreement for the purchase and installation of these Work Stations ("Agreement"); and

WHEREAS, the City's participation in the Agreement will facilitate acquisition of these Work Stations as well as provide considerable cost benefits to the City; and

WHEREAS, if the City had to go to formal bid rather than participate in the Agreement considerably more funds would be required;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. The above recitals are true and correct and are incorporated herein by this reference.

Section 2. The City Manager or designee of the City is hereby authorized

1 to enter an agreement and any amendments thereto with Snap-On Industrial, a division
2 of IDSC HOLDINGS LLC "Snap-On Industrial" for the purchase and installation of 41
3 technician work stations of substantially the same type and kind purchased by the
4 Corona-Norco Unified School District pursuant to the Agreement except as modified by
5 mutual agreement of the City and "Snap-On Industrial", and the purchase by the City
6 shall be on the same terms and conditions afforded to the Corona-Norco Unified School
7 District in an amount not to exceed Two Hundred Seventy Thousand One Hundred
8 Seventy Six Dollars (\$270,176) including tax and shipping, for the first year, with the
9 option to renew for two additional one-year periods for an annual amount not to exceed
10 \$50,000, at the discretion of the City Manager.


11 Section 3. This resolution shall take effect immediately upon its adoption
12 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
