1 FIRST AMENDMENT TO CONTRACT NO. 34711

3 THIS FIRST AMENDMENT TO CONTRACT NO. 34711 is entered into, in
4 duplicate, effective as of June 2, 2021, for reference purposes only, pursuant to a minute
5 order adopted by the City Council of the City of Long Beach at its meeting held on May 11,
6 2021, by and between CENTRO C.H.A. INC., a California nonprofit corporation with offices
7 located at 1633 Long Beach Boulevard, Long Beach, California 90813 ("Contractor") and
8 the CITY OF LONG BEACH, a municipal corporation ("City") and administering entity for
9 Pacific Gateway Workforce Investment Network.

10 WHEREAS, City and Contractor (the "Parties") entered into Contract No.
11 34711 (the "Contract") whereby Contractor agreed to provide outreach and recruitment,
12 including development of assessment tools; and

13 WHEREAS, the Parties desire to extend the term;

14 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
15 conditions herein contained, the Parties agree as follows:

16 1. Section 2.A. of the Contract is hereby amended to read as follows:

17 "A. The term of this Contract ("Term") shall be deemed to have
18 commenced as of July 1, 2017, and unless sooner terminated pursuant to the provisions
19 hereof, shall terminate on June 30, 2021. Either of the parties hereto shall have the right
20 to terminate this Contract in its entirety at any time during the Term for any or no reason
21 whatsoever by giving fifteen (15) days prior written notice of termination to the other party.
22 City shall have the additional right to cancel any part of this Contract at any time during the
23 Term for any reason whatsoever by giving fifteen (15) days' notice of such cancellation to
24 the Contractor."

25 2. Except as expressly modified herein, all of the terms and conditions
26 contained in Contract No. 34711 are ratified and confirmed and shall remain in full force
27 and effect.
