



If they are successful in this venture, our business, which has been a staple of this community for more than 25 years and one that my family has had the pleasure of being a part of for nearly 3 years now, would surely suffer as result. The local bar, Poor Richard's and also Around the Corner Liquor would also be affected. Speaking with locals the past few weeks since this was brought to everyone's attention, it's become clear that the majority of people feel that this neighborhood didn't need another convenience store let alone one that will sell alcoholic beverages. As the city of Long Beach knows, this location is open 24 hours a day. Meaning they will be able to sell beer and wine up until 2 a.m. when we close at 12 a.m. and stop selling a half hour before hand. Some may say that's all the more reason to have another option for those few hours but that will only bring the local area down in terms of safety. It's a firm stance that many in our community share and attached to this letter we have petition with more than 100 signatures that echo that sentiment. We hope that you consider our view on the matter and that their request for this license is denied.
