HONORABLE MAYOR AND CITY COUNCIL City of Long Beach California

RECOMMENDATION:

Adopt a Resolution authorizing the City Manager, or designee, to apply for grant funds through the California Department of Resources Recycling and Recovery (CalRecycle), authorizing submittal of applications for all CalRecycle grants for which the City of Long Beach is eligible, accept the grant funds, if awarded, and execute all documents necessary to implement the purposes of the grant, for a period of five years from the date of adoption of the Resolution. (Citywide)

DISCUSSION

The Public Resources Code sections 40000 et seq. authorize CalRecycle, formerly known as the California Integrated Waste Management Board, to administer various Grant Programs in furtherance of the State of California's efforts to reduce, recycle, and reuse solid waste generated in California thereby preserving landfill capacity and protecting public health, safety, and the environment.

The City is eligible for funding from CalRecycle's annual grant opportunities to assist with establishing beverage container recycling, litter abatement projects, develop or expand household hazardous waste collection education and source reduction, assist with tire recycling, cleanup and enforcement, and to encourage appropriate disposal and recycling of used motor oil.

CalRecycle grant application procedures require an applicant's governing body to declare by Resolution certain authorizations related to the administration of CalRecycle grants. This Resolution will replace RES-13-0066, which is due to expire on August 13, 2018. No other changes are being requested.

This matter was reviewed by Deputy City Attorney Amy R. Webber on May 29, 2018 and by Revenue Management Officer Geraldine Alejo on June 1, 2018.

SUSTAINABILITY

Long Beach's Sustainable City Action Plan, which was approved by the City Council on February 2, 2010, includes a goal to reduce the average pounds of solid waste generated per person per day.

Leveraging these grant funding opportunities will assist the City to reduce consumption and waste by implementing programs to facilitate waste reduction, encourage reuse of resources, and provide recycling opportunities for residents and businesses within Long Beach.

TIMING CONSIDERATIONS

City Council action on this matter is requested on June 19, 2018, to provide the Resolution necessary to be considered for future CalRecycle grants.

FISCAL IMPACT

When new CalRecycle grants are awarded, City Council approval will be requested to appropriate the new grant funding. There is no fiscal or local job impact associated with this recommendation.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER, OR HIS DESIGNEE, TO SUBMIT APPLICATIONS FOR ALL CALRECYCLE GRANTS FOR WHICH THE CITY OF LONG BEACH IS ELIGIBLE

WHEREAS, the Public Resources Code sections 40000 et seq. authorize the Department of Resources Recycling and Recovery ("CalRecycle") to administer various Grant Programs ("grants") in furtherance of the State of California's ("State") efforts to reduce, recycle and reuse solid waste generated in the State thereby preserving landfill capacity and protecting public health and safety and the environment; and

WHEREAS, in furtherance of this authority CalRecycle is required to establish procedures governing the application, awarding, and management of the grants; and

WHEREAS, CalRecycle grant application procedures require, among other things, an applicant's governing body to declare by resolution certain authorizations related to the administration of CalRecycle grants;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. The City Council of the City of Long Beach authorizes the submittal of application(s) to CalRecycle for all grants for which the City of Long Beach is eligible.

Section 2. The City Manager, or designee, is hereby authorized and empowered to execute in the name of the City of Long Beach all grant documents, including but not limited to, applications, agreements, amendments and requests for payment, necessary to secure grant funds and implement the approved grant project.
