

1 FIRST AMENDMENT TO AGREEMENT NO. 33347

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 33347 is made and
4 entered, in duplicate, as of June 15, 2015, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 November 12, 2013, by and between JOHN BEAN TECHNOLOGIES CORPORATION
7 DBA JBT AEROTECH, a Delaware corporation ("Consultant"), with a place of business at
8 1805 W. 2550 South, Ogden, Utah 84401, and the CITY OF LONG BEACH, a municipal
9 corporation ("City").

10 WHEREAS, City requires specialized services requiring unique skills to be
11 performed in connection with maintenance and capital improvements for the baggage
12 handling and conveyance systems at the Long Beach Airport; and

13 WHEREAS, the parties entered Agreement No. 33347 whereby Consultant
14 agreed to provide these Services; and

15 WHEREAS, the parties desire to extend the term and increase the
16 Agreement amount by \$300,000;

17 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
18 conditions in this Agreement, the parties agree as follows:

19 1. Section 1.A. of Agreement No. 33347 is hereby amended and
20 restated to read as follows:

21 A. Consultant shall furnish specialized services more particularly
22 described in the written Specifications 34 7716 (RFP 13-034) and otherwise described in
23 Exhibit "A" attached to this Agreement and incorporated by this reference, in accordance
24 with the standards of the profession, and City shall pay for these services in the manner
25 described below, not to exceed One Million Four Hundred Fourteen Thousand Nine
26 Hundred Ninety-One Dollars (\$1,414,991), at the rates or charges shown in Exhibit "B".

27 2. Section 2 of Agreement No. 33347 is hereby amended and restated
28 to read as follows:

1 "2. TERM. The term of this Agreement shall commence at midnight on
2 November 1, 2013, and shall terminate at 11:59 p.m. on October 31, 2016, unless sooner
3 terminated as provided in this Agreement, or unless the services or the Project is
4 completed sooner. The parties have the option to renew this Agreement for one
5 additional one-year term."

6 3. Except as expressly modified herein, all of the terms and conditions
7 contained in Agreement No. 33347 are ratified and confirmed and shall remain in full
8 force and effect.
