WHEREAS, City and Consultant again desire to increase the total not to exceed amount and extend the term;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions in this Amendment, the parties agree as follows:

- 1. Section 1.A of the Agreement is hereby amended to read as follows:
 - "A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to the Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, a total not to exceed contract
