## SECOND AMENDMENT TO AGREEMENT NO. 35625

THIS SECOND AMENDMENT TO AGREEMENT NO. 35625 is made and entered, in duplicate, as of May 3, 2023, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on June 9, 2020, by and between CONVERGEONE, INC., a Minnesota corporation ("Consultant"), with a place of business at 10900 Nesbitt Avenue South, Bloomington, Minnesota 55437, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35625 (the "Agreement") whereby Consultant agreed to provide as-needed professional and technical services for system analysis, development, implementation, project management, and technical support for information technology projects and systems; and

WHEREAS, the Parties entered into a First Amendment to extend the term one (1) additional one-year period to June 30, 2023; and

WHEREAS, the Parties desire to extend the term one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 2 of the Agreement is hereby amended to read as follows:
- "2. <u>TERM</u>. The term of this Agreement shall commence at midnight on July 1, 2020, and shall terminate at 11:59 p.m. on June 30, 2024, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. The Term may be extended for one (1) additional one-year periods, at the discretion of the City Manager."
- Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 35625 are ratified and confirmed and shall remain in full force and effect.
