

RESOLUTION NO. RES-20-0026

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH DELL MARKETING L.P. TO PROVIDE PRODUCT LICENSES AND SUPPORT SERVICES ON THE SAME TERMS AND CONDITIONS AFFORDED TO THE COUNTY OF RIVERSIDE, CALIFORNIA, THROUGH THE LICENSING SOLUTION PROVIDER AGREEMENT NO. PSA-0001524 AND MASTER MICROSOFT ENTERPRISE AGREEMENT NO. 8084445

WHEREAS, the Charter of the City of Long Beach (the "City"), Section 1802, permits the City to purchase services, supplies, materials, equipment and labor with other government agencies by purchasing under their contracts on a voluntary and selective basis when authorized by resolution; and

WHEREAS, the City of Long Beach desires Microsoft product licenses and support services; and

WHEREAS, the County of Riverside, California has a Licensing Solution provider Agreement, No. PSA-0001524, and a Master Microsoft Enterprise Agreement, No. 8084445 with Dell Marketing L.P. (together the "Riverside Agreements"); and

WHEREAS, the City's participation in the Riverside Agreements will facilitate timely acquisition of the Microsoft product licenses and support services as well as provide considerable cost benefits to the City; and

WHEREAS, if the City had to utilize a formal bid process rather than participate in the Riverside Agreements considerably more funds would be required;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as

2                   Section 1.    The above recitals are true and correct and are incorporated  
3 herein by this reference.

4                   Section 2.    The City Manager or designee is hereby authorized to enter  
5 an agreement with Dell Marketing L.P. to furnish and deliver Microsoft product licenses  
6 and support services on the same terms and conditions afforded to the County of  
7 Riverside, California, through Licensing Solution Provider Agreement Number PSA-  
8 0001524 and Master Microsoft Enterprise Agreement No. 8084445, in an amount not to  
9 exceed Nine Hundred Seven Thousand Dollars (\$907,000) for the first year, an annual  
10 amount not to exceed One Million Two Hundred Nine Thousand Dollars (\$1,209,000) for  
11 the second year, plus a twenty percent (20%) contingency in the amount of Four Hundred  
12 Twenty-Three Thousand Dollars (\$423,000), for a total amount not to exceed Two million  
13 Five Hundred Thirty-Nine Thousand Two Hundred Dollars (\$2,539,200), until the current  
14 contract expires on October 31, 2021, with the option to renew for as long as the County  
15 of Riverside Agreements are in effect, for an annual amount of One Million Five Hundred  
16 Twenty-Two Thousand Dollars (\$1,522,000), with a twenty percent (20%) contingency of  
17 Three Hundred Four Thousand Four Hundred Dollars (\$304,400), for a total amount not  
18 to exceed One Million Eight Hundred Twenty-Six Thousand Four Hundred Dollars  
19 (\$1,826,400) at the discretion of the City Manager.

20                   Section 3.    This resolution shall take effect immediately upon its adoption  
21 by the City Council, and the City Clerk shall certify the vote adopting this resolution.


