

FIRST AMENDMENT TO AGREEMENT NO. 32075

THIS FIRST AMENDMENT TO AGREEMENT NO. 32075 is made and entered, in duplicate, as of January 10, 2012, for reference purposes only pursuant to Resolution No. RES-10-0142 adopted by the City Council of the City of Long Beach at its meeting on November 16, 2010, by and between CONSOLIDATED FABRICATORS CORPORATION, a California corporation ("Contractor"), with a place of business located at 14620 Arminta Street, Van Nuys, California 91402, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the City desires to purchase commercial trash containers; and WHEREAS, the parties entered Agreement No. 32075 whereby Contractor agreed to provide such trash containers; and

WHEREAS, the parties desire to extend the term of the Agreement and add \$95,000 for a total not to exceed amount of \$190,000;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions in Agreement No. 32075 and herein, the parties agree as follows:

1. Section 1.B. of Agreement No. 32075 is hereby amended in its entirety to read as follows:

"1.

B. Contractor shall sell, furnish and deliver to the City commercial trash containers of substantially the same type and kind purchased by the Los Angeles Community College District and on the same terms and conditions offered to the Los Angeles Community College District, for an amount not to exceed One Hundred Ninety Thousand Dollars (\$190,000) for the term ending February 1, 2013, including tax and shipping. The parties have the option to renew this Agreement for one (1) additional one (1) year period, extending until the warranty on the commercial trash containers expires. To the extent that the District Contract and this Agreement are inconsistent, the following priority shall govern: (1) this Agreement and (2) the District Contract."

force and effect.
