FIRST AMENDMENT TO AGREEMENT NO. 32075

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 32075 is made and
4 entered, in duplicate, as of January 10, 2012, for reference purposes only pursuant to
5 Resolution No. RES-10-0142 adopted by the City Council of the City of Long Beach at its
6 meeting on November 16, 2010, by and between CONSOLIDATED FABRICATORS
7 CORPORATION, a California corporation ("Contractor"), with a place of business located
8 at 14620 Arminta Street, Van Nuys, California 91402, and the CITY OF LONG BEACH, a
9 municipal corporation ("City").

10 WHEREAS, the City desires to purchase commercial trash containers; and

11 WHEREAS, the parties entered Agreement No. 32075 whereby Contractor
12 agreed to provide such trash containers; and

13 WHEREAS, the parties desire to extend the term of the Agreement and add
14 \$95,000 for a total not to exceed amount of \$190,000;

15 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
16 conditions in Agreement No. 32075 and herein, the parties agree as follows:

17 1. Section 1.B. of Agreement No. 32075 is hereby amended in its
18 entirety to read as follows:

19 "1.

20 B. Contractor shall sell, furnish and deliver to the City commercial trash
21 containers of substantially the same type and kind purchased by the Los Angeles
22 Community College District and on the same terms and conditions offered to the Los
23 Angeles Community College District, for an amount not to exceed One Hundred Ninety
24 Thousand Dollars (\$190,000) for the term ending February 1, 2013, including tax and
25 shipping. The parties have the option to renew this Agreement for one (1) additional one
26 (1) year period, extending until the warranty on the commercial trash containers expires.
27 To the extent that the District Contract and this Agreement are inconsistent, the following
28 priority shall govern: (1) this Agreement and (2) the District Contract."

1 2. Except as expressly modified herein, all of the terms and conditions
2 contained in Agreement No. 32075 are ratified and confirmed and shall remain in full
3 force and effect.

4 IN WITNESS WHEREOF, the parties have caused this document to be duly
5 executed with all formalities required by law as of the date first stated above.
