Agreement With the County of Los Angeles Probation Department to Provide a Full-Time Deputy Probation Officer for Gang Crime

Suppression Services (Citywide)

## **DISCUSSION**

On July 15, 2003, the City Council authorized the City Manager to accept an additional round of funding from the Department of Justice, Bureau of Justice Assistance Local Law Enforcement Block Grants (LLEBG) program. Funds have been set aside in this grant to contract with the County of Los Angeles to provide a full-time Deputy Probation Officer to render gang crime suppression services for the City of Long Beach.

The Deputy Probation Officer assigned to the Gang Enforcement Section will continue to work with both adult and juvenile offenders. The terms of this agreement will be for a period of 12 months, commencing July 1, 2004 through June 30, 2005, and are consistent with the agreement executed in the previous year (Contract No. 28365). This agreement may be terminated at any time with thirty (30) days' written notice to the other party.

This matter was reviewed by Deputy City Attorney J. Charles Parkin on May 18, 2004 and Budget Manager Michael Killebrew on May 14, 2004.

#### TIMING CONSIDERATIONS

City Council action on this matter is requested on June 1, 2004 to guarantee uninterrupted service, as the current agreement expires on June 30, 2004.

## FISCAL IMPACT

The Police Department will use specifically budgeted LLEBG funds in the General Grants Fund (SR 120) to reimburse the County of Los Angeles. For the remainder of the agreement, sufficient funds will be budgeted through the FY 05 budget process. LLEBG funds will offset the total billable amount, not to exceed \$110,000 for the 12-month period.

## IT IS RECOMMENDED THAT THE CITY COUNCIL:

Authorize the City Manager to execute the agreement and any subsequent amendments, with an option for two one-year renewals subject to fund availability, with the County of Los Angeles Probation Department to provide a full-time Deputy Probation Officer for gang crime suppression services in an amount not to exceed \$110,000 for a 12-month term.
