3 THIS FOURTH AMENDMENT TO AGREEMENT NO. 34185 is made and  
4 entered, in duplicate, as of October 9, 2020 for reference purposes only, pursuant to a  
5 minute order adopted by the City Council of the City of Long Beach at its meeting on  
6 October 6, 2020, by and between ANCHOR QEA, LLC, a Washington limited liability  
7 company ("Consultant"), with a place of business at 1 Pacific Plaza, 7755 Center Avenue,  
8 Suite 1060, Huntington Beach, California 92647, and the CITY OF LONG BEACH, a  
9 municipal corporation ("City").

10 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.  
11 34185 (the "Agreement") whereby Consultant agreed to provide as-needed professional  
12 engineering services; and

13 WHEREAS, the Parties entered into a First Amendment to the Agreement to  
14 add \$2,000,000 for a total not to exceed amount of \$5,000,000; and

15 WHEREAS, the Parties entered into a Second Amendment to the Agreement  
16 to extend the term to December 31, 2019; and

17 WHEREAS, the Parties entered into a Third Amendment to the Agreement  
18 to add \$200,000 for a total not to exceed amount of \$5,200,000 and extend the term to  
19 December 31, 2020; and

20 WHEREAS, the Parties desire to extend the term one (1) additional one-year  
21 period;

22 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
23 conditions herein contained, the Parties agree as follows:

- 24 1. Section 2 of the Agreement is hereby amended to read as follows:  
25 "2. TERM. The term of this Agreement shall commence at midnight on  
26 January 1, 2016, and shall terminate at 11:59 p.m. on December 31, 2021, unless sooner  
27 terminated as provided in this Agreement, or unless the services or the Project is  
28 completed sooner."
