

FIRST AMENDMENT TO AGREEMENT NO. 35241

THIS FIRST AMENDMENT TO AGREEMENT NO. 35241 is made and entered, in duplicate, as of July 30, 2019, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on January 22, 2019, by and between PEDAL MOVEMENT LLC, a California limited liability company ("Consultant" and "Contractor"), with a place of business at 223 E. First Street, Long Beach, California 90802, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35241 whereby Consultant agreed to perform ongoing operation and maintenance of the Long Beach Bike Share Program; and

WHEREAS, the Parties desire to extend the term;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 2 of Agreement No. 35241 is hereby amended to read as follows:

"2. TERM. The term of this Agreement shall commence at midnight on January 1, 2019, and shall terminate at 11:59 p.m. on December 31, 2020, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. The term may be extended for three (3) additional one-year periods, at the discretion of the City Manager."

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 35241 are ratified and confirmed and shall remain in full force and effect.


