CONTRACT CHANGE ORDER AUTHORIZATION NO. 9

PART 1 (Reason for Change)

1.1 Change Order was issued to revise the mechanical screen material and welded to the structural steel.

- 1.2 Change Order was issued because field modification to the structural steel was required to receive the new design build joist trusses. The structural engineer of record under the architect refused to answer the RFI questions by the truss manufacturer. Two truss manufacturers asked to be relieved from their contract due to lack of structural data from the structural engineer of record and is why we missed our window of opportunity to coordinate the structural steel shop drawings.
- 1.3 Change Order was issued to add a diagonal brace at the stairs, which were design build, by the general contractor. The general contractor says the diagonal brace at the stairs was added under the structural engineers request after the stairs were installed.
- 1.4 Change Order was issued to install a stainless steel bike rack per the architect's detail. The contract drawings had two conflicting bike rack details, one by the architect for stainless steel and one by City standard for galvanized metal.
- 1.5 Change order was required to demo the non-structural furring strips for which the hard lid ceiling was attached to because the contractor says that although the demo plans call for demolishing the hard lid ceiling, they say the language in the demo drawings didn't extend to the furring strips even though all the rooms indicated a new t-bar ceiling.
- 1.6 Change Order was issued to create wider door openings in the existing cmu where doors were called out to be demolished for new wider doors to satisfy ADA requirements.

PART 2 (Description of Change)

- 2.1 Provide all labor, materials and equipment to revise the metal mechanical screens to galvanized painted metal and welded to the structural steel.
- 2.2 Provide all labor, materials and equipment to hire a welder in the field to make modifications to the structural steel in place.
- 2.3 Provide all labor, materials and equipment to install a steel cross brace at the new stairs after the stairs were installed.
- 2.4 Provide all labor, materials and equipment for the premium difference of installing a stainless steel bike in lieu of galvanized steel.
- 2.5 Provide all labor, materials and equipment to demo the existing non-bearing furring strips installed for the hard lid ceiling at various rooms on both the first and second floor.
- 2.6 Provide all labor, materials and equipment to saw cut wider door openings at various locations on both the first and second floor.

- 1. Provide all labor, materials and equipment to install field painted metal screens on the roof to shield the mechanical equipment as directed by the Architect. For the lump sum cost of.....\$ 13.500.00
- 2. Provide all labor, materials and equipment to field weld modification to the structural steel in place to receive the new truss joists for the new second floor. For the lump sum cost of.....\$ 5,322.43
- 3. Provide all labor, materials and equipment to install a steel cross brace at the stairs as directed by the Structural Engineer of Record. For the lump sum cost of.....\$ 2,909.91
- 4. Provide all labor, materials and equipment to cover the premium cost of revising the material of the bike rack from galvanized steel to stainless steel as directed by the Architect. For the lump sum cost of......\$
- 5. Provide all labor, materials, equipment and disposal to demo the furring strips in the ceiling. For the lump sum cost of......\$
- 6. Provide all labor, materials, equipment and disposal to saw cut the cmu for wider door openings. For the lump sump cost of.....\$
