

1 FIRST AMENDMENT TO AGREEMENT NO. 34105

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 34105 is made and
4 entered, in duplicate, as of December 14, 2016, for reference purposes only, pursuant to
5 a minute order adopted by the City Council of the City of Long Beach at its meeting on
6 October 20, 2015, by and between HNTB CORPORATION, a Delaware corporation
7 (“Consultant”), with a place of business at 200 E. Sandpointe Avenue, Suite 200, Santa
8 Ana, California 92707, and the CITY OF LONG BEACH, a municipal corporation (“City”).

9 WHEREAS, City requires specialized services requiring unique skills to be
10 performed in connection with planning and engineering consulting services for the Airfield
11 Geometry Study Phase 2 at the Long Beach Airport; and

12 WHEREAS, City and Consultant entered into Agreement No. 34105 whereby
13 Consultant agreed to provide these services; and

14 WHEREAS, City and Consultant desire to extend the term;

15 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
16 conditions in the Agreement and this Amendment, the parties agree as follows:

17 1. Section 2 of Agreement No. 34105 is hereby amended to read as
18 follows:

19 “2. TERM. The term of this Agreement shall commence at midnight on
20 November 9, 2015, and shall terminate at 11:59 p.m. on November 8, 2017, unless sooner
21 terminated as provided in this Agreement, or unless the services or the Project is
22 completed sooner.”

23 2. Except as expressly modified herein, all of the terms and conditions
24 contained in Agreement No. 34105 are ratified and confirmed and shall remain in full force
25 and effect.






