1 FIRST AMENDMENT TO AGREEMENT NO. 34180

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 34180 is made and
4 entered, in duplicate, as of February 5, 2018 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 December 15, 2015, by and between KOA CONSULTING, INC., a California corporation
7 ("Consultant"), with a place of business at 419 Main Street, Suite 320, Huntington Beach,
8 California 92648, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City requires specialized services requiring unique skills to be
10 performed in connection with as-needed professional engineering services; and

11 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
12 34180 (the "Agreement") whereby Consultant agreed to provide these specialized
13 services; and

14 WHEREAS, the Parties desire to add \$1,500,000 to the Agreement;

15 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
16 conditions herein contained, the Parties agree as follows:

17 1. Section 1.A. of the Agreement is hereby amended to read as follows:

18 "A. Consultant shall furnish specialized services more particularly
19 described in Exhibit "A", attached to this Agreement and incorporated by this
20 reference, in accordance with the standards of the profession, and City shall pay for
21 these services in the manner described below, not to exceed Four Million Five
22 Hundred Thousand Dollars (\$4,500,000), at the rates or charges shown in Exhibit
23 "B"."

24 2. Except as expressly amended herein, all terms and conditions in
25 Agreement No. 34180 are ratified and confirmed and shall remain in full force and effect.






