

FIRST AMENDMENT TO CONTRACT NO. 35083

THIS FIRST AMENDMENT TO CONTRACT NO. 35083 is entered into, in duplicate, effective as of June 12, 2019, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on July 18, 2017, by and between SJM CONSULTING, LLC, a Pennsylvania limited liability company ("Contractor"), with offices located at 506 E. Murdoch Road, Philadelphia, Pennsylvania 19119, and the CITY OF LONG BEACH, a municipal corporation ("City") and administering entity for Pacific Gateway Workforce Investment Network.

WHEREAS, City and Contractor (the "Parties") entered into Contract No. 35083 whereby Contractor agreed to provide Pacific Gateway Workforce Investment Network (PGWIN) deliverables such as economic competitiveness and asset mapping, sector opportunities study, and entrepreneurial accelerator; and

WHEREAS, the Parties desire to extend the term of Contract No. 35083 one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 2.A. of Contract No. 35083 is hereby amended to read as follows:

"A. The term of this Contract ("Term") shall be deemed to have commenced as of July 1, 2018, and unless sooner terminated pursuant to the provisions hereof, shall terminate on June 30, 2020. Either of the parties hereto shall have the right to terminate this Contract in its entirety at any time during the Term for any or no reason whatsoever by giving fifteen (15) days prior written notice of termination to the other party. City shall have the additional right to cancel any part of this Contract at any time during the Term for any reason whatsoever by giving fifteen (15) days' notice of such cancellation to the Contractor."

2. Except as expressly amended herein, all terms and conditions in
