ORDINANCE NO.

AN ORDINANCE OF THE CITY COUNCIL OF THE
CITY OF LONG BEACH AMENDING THE LONG BEACH
MUNICIPAL CODE BY AMENDING SECTION 10.32.110
RELATING TO PREFERENTIAL PARKING DISTRICT "U"

WHEREAS, residents on San Vicente Avenue between Marita Street and Los Santos Drive have requested inclusion in Preferential Parking District "U" to seek on-street parking relief due to overflow parking generated by CSU Long Beach students; and

WHEREAS, the residents have requested that a one-hour parking restriction, from 9:00 a.m. to 9:00 p.m., Monday through Friday, except Saturdays, Sundays and holidays, be established within the proposed preferential parking district expansion; and

WHEREAS, a parking study conducted by staff during the peak period of activity on San Vicente Avenue revealed that eighty-three percent (83%) of existing on-street parking spaces within the block area were occupied at the time of the survey and that ninety-six percent (96%) of the vehicles were not registered to residents of the neighborhood; and

WHEREAS, a petition formally requesting the expansion of Preferential Parking District "U" and a one-hour parking restriction from 9:00 a.m. to 9:00 p.m., Monday through Friday, except Saturdays, Sundays and holidays, was circulated among the residents; and

WHEREAS, a review of the petition by staff revealed that eighty-three percent (83%) of the residents are in favor of implementing a preferential parking district and the proposed parking restrictions; and

WHEREAS, in order to prevent parking spillover into the blocks adjacent to the proposed preferential parking district, the City Traffic Engineer is proposing to expand

1 the preferential parking district to include streets that may be impacted; and

2 WHEREAS, the City Traffic Engineer has reviewed the results of the
3 parking study, the resident petition and the feedback responses from the mailing, and he
4 has determined that conditions meet minimum municipal code criteria as outlined in
5 LBMC 10.32.020 for inclusion in the preferential parking district;

6 NOW, THEREFORE, the City Council of the City of Long Beach does
7 hereby ordain as follows:

8
9 Section 1. District "U" of Section 10.32.110 of the Long Beach Municipal
10 Code is hereby amended to read as follows:

11 District U: The west side of Britton Drive between Atherton Street
12 and Marita Street; both sides of Britton Drive between Marita Street and Los
13 Santos Drive; both sides of Marita Street between Britton Drive and Fanwood
14 Avenue; both sides of Lave Avenue between Atherton Street and Los Santos
15 Drive; the east side of San Anseline Avenue between Atherton Street and Los
16 Santos Drive; both sides of San Vicente Avenue between Marita Street and
17 Los Santos Drive; both sides of Garford Street between San Vicente Avenue
18 and Los Santos Drive; and both sides of Fairbrook Street between San
19 Vicente Avenue and Los Santos Drive.

21 Section 2. The City Clerk shall certify to the passage of this ordinance by
22 the City Council and cause it to be posted in three (3) conspicuous places in the City of
23 Long Beach, and it shall take effect on the thirty-first (31st) day after it is approved by the
24 Mayor.
