RE: Notice of Appeal Hearing Pursuant to Long Beach Municipal Code Section 21.21.507


Please take notice that your appeal to the Long Beach City Council filed June 23, 2014, will come before the City Council in the City Council Chambers in City Hall, 333 West Ocean Boulevard, Long Beach, California on August 19, 2014 at 5:00 p.m. or as soon thereafter as the matter can be heard. The appeal concerns the California Environmental Quality Act determinations made on June 9, 2014, by the Board of Harbor Commissioners in connection with the approval of the Operating Agreement with Metropolitan Stevedore Company and the Lease with Oxbow Energy Solutions LLC.

The hearing shall be conducted in accordance with Long Beach Municipal Code Section 21.21.507. During the hearing, a spokesperson for the appellant and a spokesperson for the Long Beach Harbor Department will be given an opportunity to present their positions, and public comment will be taken.

If you subsequently challenge the determination in court, in addition to the limitations contained in Long Beach Municipal Code Section 21.21.507.E.3, you may be limited to raising only the issues your spokesperson or someone else raised orally or in writing in both the proceedings before the Board of Harbor Commissioners and in the proceedings described in this notice.
