A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH WEST **ENTERPRISES** INC. DBA **UNIGLOBE TRAVEL** DESIGNERS. OF COLUMBUS. OH. FOR AS-NEEDED TRAVEL MANAGEMENT. TRAVEL **EXPENSE** MANAGEMENT AND RELATED SERVICES, ON THE SAME TERMS AND CONDITIONS AFFORDED TO THE REGION 4 EDUCATION SERVICE CENTER (ESC), THROUGH OMNIA PARTNERS IN A TOTAL AMOUNT \$250,000, WITH A 20 PERCENT CONTINGENCY OF \$50,000, FOR A TOTAL ANNUAL CONTRACT NOT TO EXCEED \$300,000 UNTIL THE OMNIA PARTNERS CONTRACT EXPIRES ON NOVEMBER 30, 2024, WITH THE OPTION TO RENEW FOR AS LONG AS OMNIA PARTNERS CONTRACT IS IN EFFECT, AT THE DISCRETION OF THE CITY MANAGER

WHEREAS, the Charter of the City of Long Beach (the "City"), Section 1802, permits the City to purchase services, supplies, materials, equipment and labor with other government agencies by purchasing under their contracts on a voluntary and selective basis when authorized by resolution; and

WHEREAS, the City desires to contract for as-needed travel management, travel expense management and related services; and

WHEREAS, the Purchasing Division of Financial Management researched procurement options for as-needed travel management, travel expense management and related services and discovered other agencies had completed an open, fair, transparent,

and competitive procurement process; and

WHEREAS, West Enterprises Inc., DBA Uniglobe Travel Designers, of Columbus, OH has a cooperative agreement with Region 4 Education Service Center (ESC), through Omnia Partners ("Region 4 ESC Contract") which would provide the best value for as-needed travel management, travel expense management and related services; and

WHEREAS, the City's participation in the Region 4 ESC Contract will facilitate the City's ability to obtain as-needed travel management, travel expense management and related services as well as provide considerable cost benefits to the City; and

WHEREAS, if the City had to utilize a formal bid process rather than participate in the Region 4 ESC Contract, considerably more funds would be required;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. The above recitals are true and correct and are incorporated herein by this reference.

Section 2. The City Manager or designee is hereby authorized to enter an agreement with West Enterprises Inc., DBA Uniglobe Travel Designers, of Columbus, OH of the same type and kind as identified in the Region 4 ESC Contract through Omnia Partners with West Enterprises Inc., DBA Uniglobe Travel Designers, of Columbus, OH, except as modified by mutual agreement of the City and West Enterprises Inc DBA Uniglobe Travel Designers of Columbus, OH. The agreement shall be on the same terms and conditions afforded under the Region 4 ESC Contract in an amount not to exceed Two Hundred Fifty Thousand Dollars (\$250,000), with a twenty percent (20%) contingency of Fifty Thousand Dollars (\$50,000), for a total annual agreement not to exceed Three Hundred Thousand Dollars (\$300,000) until the Omnia Partners contract expires on November 30, 2024, with the option to renew for as long as the Omnia Partners contract is in effect, at the discretion of the City Manager.
