

RESOLUTION NO. RES-23-0027

A RESOLUTION OF THE CITY COUNCIL OF THE  
CITY OF LONG BEACH PROCLAIMING THE  
TERMINATION OF A LOCAL EMERGENCY AND A LOCAL  
HEALTH EMERGENCY, ALL RELATING TO NOVEL  
CORONAVIRUS (COVID-19)

WHEREAS, California Government Code Section 8630, California Health  
and Safety Code Section 101080, and Long Beach Municipal Code Section 2.69.060  
require the City Council to proclaim the termination of a local emergency and the  
termination of a local health emergency at the earliest possible date that conditions  
warrant; and

WHEREAS, the City Council adopted Resolution No. RES-20-0032 on  
March 10, 2020, declaring that a local emergency, as defined in Government Code  
Section 8630 existed, and ratifying the declaration by the City Health Officer of a local  
health emergency, all with respect to the threat of a Novel Coronavirus (COVID-19)  
epidemic; and

WHEREAS, there has not been a large segment of the population affected  
by the Novel Coronavirus (COVID-19), that the cases identified to date have been mild,  
and the need for resources to respond to the outbreak is decreasing; and

WHEREAS, pursuant to California Government Code Section 8630,  
California Health and Safety Code Section 101080, and Long Beach Municipal Code  
Section 2.69.060, the City Council desires to proclaim the termination of such local  
emergency and local health emergency;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as  
follows:

Section 1. That the declarations of a local emergency (as defined in

2 a local health emergency (as defined in Health and Safety Code Section 101080), all  
3 relating to Novel Coronavirus (COVID-19) in the City of Long Beach established by  
4 Resolution No. RES-20-0032 are hereby terminated.

5 Section 2. Resolution No. RES-20-0032 is hereby rescinded.

6 Section 3. This resolution shall take effect immediately upon its adoption  
7 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
