

1 THIRD AMENDMENT TO AGREEMENT NO. 35443

3 THIS THIRD AMENDMENT TO AGREEMENT NO. 35443 is made and
4 entered, in duplicate, as of January 18, 2023 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 November 19, 2019, by and between TRAUMA INTERVENTION PROGRAMS, INC., a
7 California corporation, with a place of business at, 1420 Phillips Street, Vista, CA, 92083,
8 hereinafter referred to as "TIP" and/or "Contractor", and the CITY OF LONG BEACH, a
9 municipal corporation ("City").

10 WHEREAS, City requires specialized services requiring unique skills to be
11 performed in connection with emotional and practical support services to victims of
12 traumatic events and their families; and

13 WHEREAS, City and Contractor (the "Parties") entered into Agreement No.
14 35443 (the "Contract") whereby Contractor agreed to provide these services; and

15 WHEREAS, the parties entered into a First Amendment to amend the terms
16 of the contract; and

17 WHEREAS the parties entered into a Second Amendment to extend the term
18 for an additional one-year period; and

19 WHEREAS, the parties currently desire to extend the term for one (1)
20 additional one-year period;

21 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
22 conditions herein contained, the Parties agree as follows:

23 1. Section 8 of the Agreement No. 35443 is hereby amended to read as
24 follows:

25 "8. TERM. Unless sooner terminated as provided for herein, this
26 Agreement shall end at 11:59 p.m. on January 31, 2024, unless sooner terminated as
27 provided herein. The City shall have the option to extend the term annually at the discretion
28 of the City Manager."
