### RECOMMENDATION:

Approve and authorize the Executive Director or designee to execute an Assignment, Assumption and Consent Agreement transferring all rights and responsibilities under a Parking Agreement from Fusion Nutrition, Inc. to Wasabi Grill, Inc. (Downtown - District 2)

## DISCUSSION

In March 2005, the Redevelopment Agency (Agency) approved a Parking Agreement with Fusion Nutrition, Inc., owner of Wasabi Japanese Restaurant, located at 200 Pine Avenue, to provide one (1) parking space under the Downtown Parking Management Plan to meet their code required parking. The agreement was subsequently amended in April 2006 to include one (1) additional space. In exchange for payment of an in-lieu fee, the Agency provides these two (2) off-site spaces on a non-exclusive, shared-use basis from the pool of available public parking in the Downtown.

In August 2007, Fusion Nutrition sold their business to Wasabi Grill, Inc. and assigned their Parking Agreement to the new owners. The agreement was approved as to form by Heather Mahood, Assistant City Attorney, on September 19, 2007. Agency approval is required to complete the assignment.

# ASSIGNMENT, ASSUMPTION AND CONSENT AGREEMENT

This Assignment, Assumption and Consent Agreement (this "Agreement") is made as of this \_\_\_th day of September, 2007, by and among Redevelopment Agency of the City of Long Beach, California ("Agency"), Fusion Nutrition, Inc., a California corporation ("Assignor"), and Wasabi Grill, Inc., a California corporation ("Assignee").

### RECITALS

- A. Agency and Assignor are parties to that certain Parking Agreement dated as of March 18, 2005, as amended on April 24, 2006 ("**Parking Agreement**"), pursuant to which Agency agrees to make two (2) parking spaces available to Assignor.
- B. Assignor desires to assign Assignor's right, title and interest in, to and under the Parking Agreement (the "Assignment"), and Assignee desires to accept such Assignment and assume all of Assignor's obligations under the Parking Agreement in accordance with the terms and conditions set forth in this Agreement.
- C. Assignor requesting Agency's consent to the Assignment and Assignee's assumption of the obligations thereunder. Agency is willing to consent to the Assignment.

# AGREEMENT

- 1. <u>Assignment</u>. Effective as of the date hereof (the "Effective Date"), Assignor hereby assigns to Assignee all of the Assignor's right, title and interest in, to and under the Parking Agreement.
- 2. <u>Acceptance</u>. Effective on the Effective Date, Assignee hereby accepts the assignment, transfer and conveyance of the Parking Agreement, and hereby covenants and agrees to pay all In-Lieu Fee and other sums payable to Agency under the Parking Agreement, and to keep, perform and be bound by all of the terms, covenants, conditions and obligations required to be performed by the participant of the Parking Agreement, subject to the rights, duties, and limitations, if any, set forth in this Agreement.
- 3. <u>Agency's Consent</u>. Agency hereby consents to the Assignment. This Agreement shall not be construed to modify, waive or amend any of the terms, covenants and conditions of the Parking Agreement.
