

1 FIRST AMENDMENT TO AGREEMENT NO. 34184

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 34184 is made and  
4 entered, in duplicate, as of October 11, 2018 for reference purposes only, pursuant to a  
5 minute order adopted by the City Council of the City of Long Beach at its meeting on April  
6 3, 2018, by and between GEOSYNTEC CONSULTANTS, INC., a Florida corporation  
7 ("Consultant"), with a place of business at 2100 Main Street, Suite 150, Huntington Beach,  
8 California 92648, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City requires specialized services requiring unique skills to be  
10 performed in connection with as-needed professional engineering services; and

11 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.  
12 34184 (the "Agreement") whereby Consultant agreed to provide these specialized  
13 services; and

14 WHEREAS, the Parties desire to extend the term one (1) additional one-year  
15 period;

16 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
17 conditions herein contained, the Parties agree as follows:

18 1. Section 2 of the Agreement is hereby amended to read as follows:

19 "2. TERM. The term of this Agreement shall commence at midnight on  
20 January 1, 2016, and shall terminate at 11:59 p.m. on December 31, 2019, unless sooner  
21 terminated as provided in this Agreement, or unless the services or the Project is  
22 completed sooner. The parties have the option to extend the term one (1) additional one-  
23 year period."

24 2. Except as expressly modified herein, all of the terms and conditions  
25 contained in Agreement No. 34184 are ratified and confirmed and shall remain in full force  
26 and effect.
