HONORABLE MAYOR AND CITY COUNCIL City of Long Beach California

RECOMMENDATION:

Authorize the City Manager to execute the Nineteenth Amendment to Lease No. 22897 with Jan and Michael Todd, for a period of three months, from October 1, 2015 through December 31, 2015, for the sale of Christmas trees, using a portion of the former Pacific Electric right-of-way property located between 7th Street and Ximeno Avenue. (District 3)

DISCUSSION

Jan and Michael Todd (Lessee) have been selling Halloween pumpkins and/or Christmas trees in Long Beach for the past 56 years. On April 13, 1993, the City Council approved Lease No. 22897 for the Lessee's use of a portion of the former Pacific Electric right-of-way (PE ROW) property located between Ximeno and Tremont Avenues, for the purpose of operating a seasonal Christmas tree lot. During the 2010 holiday season, it was necessary to move the Lessee to a different portion of the PE ROW, located between 7th Street and Ximeno Avenue (Premises), as shown on the aerial map (Attachment), in order to accommodate the County of Los Angeles' ongoing storm drain project. Although the County of Los Angeles is no longer occupying this area, the Lessee has requested to remain at these Premises for another year. Therefore, a Nineteenth Amendment to Lease No. 22897 is required in order to allow the Lessee to return to the Premises for the 2015 holiday season.

The proposed Nineteenth Amendment contains the following major provisions:

- Term: October 1, 2015 through December 31, 2015.
- Premises: Portion of the former PE ROW located between 7th Street and Ximeno Avenue.
- Rent: A one-time payment of \$4,000, due on or before January 15, 2016. This rent amount is unchanged from the prior lease year.
- <u>Authorized Use</u>: The premises shall be used for the seasonal sale of Christmas trees.

- Maintenance/Restoration of Premises: The Lessee shall be solely responsible for maintaining the Premises in good condition, and shall restore the Premises to its original unused state, as deemed satisfactory by the City Manager or his designee.
- The Lessee shall be solely responsible for all costs related to the Utilities: installation and use of utilities at the Premises.
- Insurance: The Lessee shall provide evidence of insurance as required and approved by the City's Risk Manager.

This matter was reviewed by Deputy City Attorney Linda Vu on July 14, 2015, and by Budget Management Officer Victoria Bell on July 20, 2015.

TIMING CONSIDERATIONS

City Council action is requested on August 18, 2015, in order to authorize the execution of the Nineteenth Amendment to Lease No. 22897.

FISCAL IMPACT

Revenue in the amount of \$4,000 will accrue to the General Fund (GF) in the Department of Parks, Recreation and Marine (PR). The recommended action will result in a positive impact on jobs. Several part-time jobs will be created by the Lessee to assist in its operation during the three-month period.

SUGGESTED ACTION:

Approve recommendation.
