SIXTH AMENDMENT TO CONTRACT NO. 34573

This Amendment is made and entered into, in duplicate, as of March 09, 2021, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on May 22, 2018, by and between DDR URBAN, LP, a Delaware limited liability company, with offices located at 95 South Pine Avenue, Long Beach, California 90802 (hereinafter referred to as "DDR") and the CITY OF LONG BEACH, a municipal corporation (hereinafter referred to as "City").

WHEREAS, the Long Beach Police Department (LBPD) provides public law enforcement services within the City of Long Beach which includes The Outlets at the Pike, commonly referred to as "The Pike" (the "Premises"); and

WHEREAS, DDR has requested the City to provide supplemental law enforcement services to the Premises over and above the law enforcement services provided to the public generally; and

WHEREAS, the parties entered Agreement No. 34573 ("Contract") whereby City agreed to provide these services; and

WHEREAS, the parties desire to extend the term of the Contract and update the schedule of rates charged by City for such services;

- 1. Section 2. of Agreement 34573 is hereby amended to read as follows:
- "2. <u>TERM</u>. Unless sooner terminated as provided for herein, this Agreement shall be for a term of one (1) year commencing on July 1, 2021, and ending on June 30, 2022. The Agreement may be extended for additional one year terms as approved by the City."
- The Rates or Charges in Exhibit "A" to the Agreement are hereby amended in accordance with Exhibit "A", attached hereto and incorporated by this reference.
- 3. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 34573 are ratified and confirmed and shall remain in full force

through their duly authorized officers effective the date first set forth herein.
