#### **AMENDMENT #7**

This amendment ("Amendment") is made this 7<sup>th</sup> day of Angust, 2018 by and between Tyler Technologies, Inc. with offices at One Tyler Drive, Yarmouth, Maine 04096 ("Tyler") and the City of Long Beach, with offices at 333 West Ocean Boulevard, 5<sup>th</sup> Floor, Long Beach, CA 90802 ("Client").

WHEREAS, Tyler and the Client are parties to an agreement dated October 10, 2016 ("Agreement"); and

WHEREAS, Tyler and Client desire to amend the terms of the Agreement as provided herein.

NOW THEREFORE, in consideration of the mutual promises hereinafter contained, Tyler and the Client agree as follows:

- 1. The items set forth in the sales quotation attached as Exhibit 1 to this Amendment are hereby added to the Agreement as of the execution date of this Amendment. Payment of fees and costs for such items shall conform to the following terms:
  - a. Services Fees & Expenses. Services added to the Agreement pursuant to this Amendment, along with applicable expenses, shall be invoiced consistent with Section 2 below as follows:

Notwithstanding anything to the contrary in the Agreement (including, but not limited to: Section I(12) Entire Agreement; Amendment), the parties agree that Client may add Tyler Forms products and services to the Agreement by signing a quote provided by Tyler. Such quote may not exceed \$5,000.00 in total value. Payment for Tyler Forms products or services added to the Agreement by signed quote will be billed individually in accordance with the Agreement.

- 4. Twenty-Four (24) unused Project Quality Services days, totaling \$42,000.00 (at a rate of \$1,750.00 per day) are hereby removed from the Agreement as of the execution date of this Amendment.
- 5. Twenty-Nine (29) Implementation days, totaling \$41,992.00 (at a rate of \$1,448.00 per day) are hereby added to the Agreement as of the execution date of this Amendment, as set forth in the Investment Summary attached hereto as Exhibit 2. Implementation Services added to the Agreement pursuant to this Amendment will be invoiced as provided and/or incurred.
  - a. The parties expect that 7 of these Implementation Days will be used for testing, training and documentation related to MUN-276157 (Project, Project Strings, Grant Updates Workflow).
  - b. The parties expect that 2 of these Implementation Days will be used for testing, training and documentation related to MUN-280672 (Max Number of Invoices per Check Global Setting).
  - c. The parties expect that 10 of these Implementation Days will be used for testing, training and documentation related to MUN-288640 (Alternate GLJ Workflow for Interface Journals).
  - d. The parties expect that 10 of these Implementation Days will be used for testing, training and documentation related to MUN-273303 (Stale Dated Check Process).
- 6. The Alternate GLJ Workflow for Interface Journals modification with Tyler Reference number MUN-288640, at a contract price of \$21,000.00, is hereby added to the Agreement. The modification will conform to the description contained in the specification document provided to Client on or about May 08, 2018. Payment for the items added to the Agreement pursuant to this Amendment shall conform to the terms of Exhibit B of the Agreement.
- 7. The Stale Dated Check Process modification with Tyler Reference number MUN-273303, at a contract price of \$14,000.00, is hereby added to the Agreement. The modification will conform to the description contained in the specification document provided to Client on or about March 16, 2018. Payment for the items added to the Agreement pursuant to this Amendment shall conform to the terms of Exhibit B of the Agreement.
- 8. The parties acknowledge that, subject to any credit restrictions, Client may use available credit issued by Tyler to cover the costs of the items being added to the Agreement pursuant to this Amendment. For Client's internal purposes, due to the removal of software and services in prior amendments, the net result of this Amendment does not exceed the original Agreement amount
- 9. This Amendment shall be governed by and construed in accordance with the terms and conditions of the Agreement.
- 10. All other terms and conditions of the Agreement shall remain in full force and effect.
