- U. Technology and Innovation Department with the following divisions: Administrative Services; Cyber Security; and the following bureaus and divisions:
- Infrastructure Services Bureau with the following divisions: Telecommunications; Wireless Communications; and Operations Center;
- Business Information Services Bureau with the following divisions: Business Information Systems; and Business Information Technology; and
- Customer Services Bureau with the following divisions:
 Customer Support; Video Communications; and Office Services.
- Section 3. The City Clerk shall certify to the passage of this ordinance by the City Council and cause it to be posted in three (3) conspicuous places in the City of Long Beach, and it shall take effect on the thirty-first (31st) day after it is approved by the Mayor.
