1 FIRST AMENDMENT TO AGREEMENT NO. 32578

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 32578 is made and  
4 entered, in duplicate, as of December 20, 2013, for reference purposes only, pursuant to  
5 a minute order adopted by the City Council of the City of Long Beach at its meeting on  
6 December 20, 2011, by and between CLARK SEIF CLARK INC. (formerly known as CSC  
7 TARGHEE, INC.), a California corporation ("Consultant"), with a place of business at 110  
8 Pine Avenue, Suite 925, Long Beach, California 90802-4455, and the CITY OF LONG  
9 BEACH, a municipal corporation ("City").

10 WHEREAS, City requires specialized services requiring unique skills to be  
11 performed in connection with on-call environmental consultant services ("Project"); and

12 WHEREAS, the parties entered Agreement No. 32578 whereby Consultant  
13 agreed to provide these Services; and

14 WHEREAS, the parties desire to extend the term and increase the total  
15 Agreement amount;

16 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
17 conditions herein contained, the parties agree as follows:

18 1. Section 1.A. of Agreement No. 32578 is hereby amended to read as  
19 follows:

20 "1. SCOPE OF WORK OR SERVICES.

21 A. Consultant shall furnish specialized services more particularly  
22 described in Exhibit "A", attached to this Agreement and incorporated by this reference,  
23 in accordance with the standards of the profession, and City shall pay for these services  
24 in the manner described below, not to exceed One Million Five Hundred Thousand  
25 Dollars (\$1,500,000), at the rates or charges shown in Exhibit "B".

26 2. Section 2 of Agreement No. 32578 is hereby amended to read as  
27 follows:

28 "2. TERM. The term of this Agreement shall commence at midnight on

1 January 1, 2012, and shall terminate at 11:59 p.m. on December 31, 2014, unless sooner  
2 terminated as provided in this Agreement, or unless the services or the Project is  
3 completed sooner.”

4 3. Except as expressly modified herein, all of the terms and conditions  
5 contained in Agreement No. 32578 are ratified and confirmed and shall remain in full  
6 force and effect.

7 IN WITNESS WHEREOF, the parties have caused this document to be duly  
8 executed with all formalities required by law as of the date first stated above.




