

1 FIRST AMENDMENT TO CONTRACT NO. 32487

3 THIS FIRST AMENDMENT TO CONTRACT NO. 32487 is made and
4 entered, in duplicate, as of November 21, 2012 for reference purposes only, pursuant to
5 a minute order adopted by the City Council of the City of Long Beach at its meeting on
6 November 20, 2012, by and between C J CONCRETE CONSTRUCTION, INC., a
7 California corporation ("Contractor"), whose address is 10142 Shoemaker Avenue, Santa
8 Fe Springs, California 90670, and the CITY OF LONG BEACH, a municipal corporation
9 ("City").

10 WHEREAS, pursuant to a "Notice Inviting Bids for Annual Contract for
11 Concrete Repairs and Related Improvements in the City of Long Beach, California,"
12 dated November 30, 2011, and published by City, bids were received, publicly opened
13 and declared on the date specified in said Notice; and

14 WHEREAS, the parties entered into Contract No. 32487 for the work
15 described in the bid documents; and

16 WHEREAS, the parties desire to extend the term and increase the Contract
17 amount by \$4,000,000 for a total not to exceed amount of \$8,000,000;

18 NOW, THEREFORE, in consideration of the terms and conditions
19 contained herein, the parties agree as follows:

20 1. Section 4 of Contract No. 32487 is hereby amended to read as
21 follows:

22 "4. TIME FOR CONTRACT. The term of this Contract shall commence
23 at midnight on January 1, 2012, and shall terminate at 11:59 p.m. on December 31, 2013,
24 unless sooner terminated as provided in this Contract, or unless the services or the
25 Project is completed sooner."

26 2. Except as expressly amended in this First Amendment, all terms and
27 conditions in Contract No. 32487 are ratified and confirmed and shall remain in full force
28 and effect.
