1 FIRST AMENDMENT TO USE PERMIT NO. 31794

3 THIS FIRST AMENDMENT TO Permit No. 31794 is made and entered,
4 pursuant to a minute order of the City Council of the City of Long Beach at its July 6,
5 2010 meeting, by and between the City of Long Beach, a municipal corporation ("City")
6 and BAC MANAGEMENT, LLC, doing business as BELMONT ATHLETIC CLUB
7 ("Permittee").

8 WHEREAS, City granted Permittee the non-exclusive use of City facilities
9 located at Livingston Drive Park and a portion of the Beach adjacent to Granada Avenue;
10 and

11 WHEREAS, the parties now desire to extend the term;

12 NOW, THEREFORE, in consideration of the mutual terms and conditions in
13 Permit No. 31794, the parties agree as follows:

14 1. Section 2 of Permit No. 31794 is hereby deleted and amended in its
15 entirety to read as follows:

16 "2. TERM. The term of this Permit shall begin on June 1, 2010 and shall
17 end on May 31, 2013. The Director shall have the option at his sole discretion to
18 extend the term of this Permit for two (2), additional one (1) year periods, provided
19 Permittee submits a written request no later than sixty (60) days prior to the
20 expiration of the Permit year."

21 2. Except as expressly stated herein, all of the terms, covenants, and
22 conditions of Permit No. 31794 are ratified and confirmed and shall remain in full force
23 and effect.
