1 FIRST AMENDMENT TO AGREEMENT NO. 35064

3 THIS THIRD AMENDMENT TO AGREEMENT NO. 35064 is made and
4 entered, in duplicate, as of September 16, 2020 for reference purposes only, pursuant to
5 a minute order adopted by the City Council of the City of Long Beach at its meeting on
6 August 7, 2018, by and between DOOLEY ENTERPRISES, INC., a California corporation
7 (“Contractor”), with a place of business at 1198 N. GROVE ST., ANAHEIM, CA 92806, and
8 the CITY OF LONG BEACH (“City”), a municipal corporation.

9 WHEREAS, City and Contractor (the “Parties”) entered into Agreement No.
10 35064 (“Agreement”) whereby Contractor agreed to provide Winchester ammunition; and

11 WHEREAS, the Parties desire to extend the term of the Agreement and
12 attach an updated rate schedule;

13 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
14 conditions herein contained, the Parties agree as follows:

15 1. Section 3. of Agreement No. 35064 is hereby amended to read as
16 follows:

17 “3. The term of this Contract shall commence on October 1, 2018, and
18 shall terminate at midnight on October 1, 2021, with the option to renew for two (2)
19 additional one (1) year periods, unless sooner terminated as provided herein. The City
20 may terminate this Contract by giving thirty (30) days prior notice of termination to
21 Contractor.”

22 2. The Rates contained in Exhibit “A-1” to this Amendment hereby
23 replace and supersede the rates attached to the Agreement. Exhibit “A-1” to this
24 Amendment is hereby incorporated into the Agreement as a replacement to Exhibit “A”.

25 3. Except as expressly modified herein, all of the terms and conditions
26 contained in Agreement No. 35064 are ratified and confirmed and shall remain in full force
27 and effect.


