

1 THIRD AMENDMENT TO AGREEMENT NO. 34316

3 THIS THIRD AMENDMENT TO AGREEMENT NO. 34316 is made and
4 entered, in duplicate, as of January 11, 2018, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 October 3, 2017, by and between MACIAS GINI & O'CONNELL LLP, a California limited
7 liability partnership fka INTELLIBRIDGE PARTNERS LLC, a California limited liability
8 company ("Consultant"), with a place of business at 3000 S Street, Suite 300, Sacramento,
9 California 95816, and the CITY OF LONG BEACH, a municipal corporation ("City").

10 WHEREAS, City requires specialized services requiring unique skills to be
11 performed in connection with as-needed professional and technical services; and

12 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
13 34316 (the "Agreement") whereby Consultant agreed to provide these services; and

14 WHEREAS, the Parties entered into a First Amendment to the Agreement to
15 extend the term and increase the total not to exceed amount to \$400,000; and

16 WHEREAS, the Parties entered into a Second Amendment to the Agreement
17 to increase the total not to exceed amount to \$800,000; and

18 WHEREAS, the Parties desire to add \$400,000 for a total not to exceed
19 amount of \$1,200,000 and extend the term one (1) additional one-year period;

20 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
21 conditions herein contained, the Parties agree as follows:

22 1. Section 1.A of the Agreement is hereby amended to read as follows:

23 A. Consultant shall furnish specialized services more particularly
24 described in Exhibit "A", attached to this Agreement and incorporated by this reference, in
25 accordance with the standards of the profession, and City shall pay for these services in
26 the manner described below, not to exceed One Million Two Hundred Thousand Dollars
27 (\$1,200,000), at the rates or charges shown in Exhibit "B".

28 2. Section 2 of the Agreement is hereby amended to read as follows:

1 "2. TERM. The term of this Agreement shall commence at midnight on
2 January 1, 2016, and shall terminate at 11:59 p.m. on January 22, 2019, unless sooner
3 terminated as provided in this Agreement, or unless the services or the Project is
4 completed sooner."

5 3. Except as expressly modified herein, all of the terms and conditions
6 contained in Agreement No. 34316 are ratified and confirmed and shall remain in full force
7 and effect.
