WHEREAS, the Parties entered into a First Amendment to the Agreement to
extend the term to August 31, 2020; and

17 to extend the term to August 31, 2021; and

WHEREAS, on August 3, 2021, the City Council authorized increasing the
aggregate not to exceed amount and extended the term to August 31, 2022, for as-needed
construction management and inspection services for all public works projects; and

21 WHEREAS, the Parties entered into a Third Amendment to the Agreement 22 to extend the term to August 31, 2022; and

WHEREAS, on July 19, 2022, the City Council authorized increasing the aggregate not to exceed amount and extended the term to August 31, 2023, for as-needed construction management and inspection services for all public works projects; and


