FOURTH AMENDMENT TO AGREEMENT NO. 33533

THIS FOURTH AMENDMENT TO AGREEMENT NO. 33533 is made and entered, in duplicate, as of June 30, 2020, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on May 19, 2020, by and between UNIQUE MANAGEMENT SERVICES, INC., a Kentucky corporation ("Consultant"), with a place of business at 119 E. Maple Street, Jeffersonville, Indiana 47130, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 33533 (the "Agreement") whereby Consultant agreed to provide library collection services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to extend the term to July 31, 2018 and attach a revised scope of work; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to extend the term to July 31, 2019; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to amend certain terms and extend the term to July 31, 2020; and

WHEREAS, the Parties desire to exercise their final option to extend the term one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 2 of the Agreement is hereby amended to read as follows:
- 2. TERM. The term of this Agreement shall commence at midnight on August 1, 2014, and shall terminate at 11:59 p.m. on July 31, 2021, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."
- 2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 33533 are ratified and confirmed and shall remain in full force
