RECOMMENDATION:

Receive the supporting documentation into the record, conclude the hearing and grant the Permit with conditions on the application of The Green Mango, Inc., DBA Golden Villa Restaurant, 1360 E. Anaheim Street, #205, for Entertainment with Dancing by Patrons. (District 2)

DISCUSSION

The Long Beach Municipal Code (LBMC) requires an application be filed and a hearing be held before the City Council whenever this type of activity is requested and before an entertainment permit is granted or denied.

The LBMC also requires that the City Council make a determination that the permit application is complete and truthful; the applicant and the officers and trustees of the entity are law-abiding persons who will operate and conduct the business activity in a lawful manner; and that public peace, welfare and safety will not be impaired. If this is so, the application shall be approved, a short-term entertainment permit shall be approved, or the application shall be denied.

The City Council has the authority to approve the following options: 1) grant the Permit, with or without conditions; or 2) grant a One-Year Short-Term Entertainment Permit, with or without conditions; or, 3) deny the Permit on the application.

City departments have conducted their investigations in accordance with the LBMC. Attached for your review are the departmental investigative reports, the business ownership and permit history, and the entertainment permit application.

The following summarizes departmental findings:

- The Police Department recommends that the permit for entertainment with dancing by patrons be approved subject to conditions.
- The Fire Department finds that the building/location meets department requirements for the proposed use.

- The Health and Human Services Department finds that the building/location meets department requirements for the proposed use with the condition that the establishment remain in compliance with the Long Beach Noise Ordinance (LBMC Chapter 8.80).
- The Development Services Department finds that the building/location meets department requirements for the proposed use.

The Department of Financial Management, Business Relations Bureau, has reviewed all submitted department documents and correspondence and, after a thorough investigative process, recommends that the permit for entertainment with dancing by patrons be approved subject to conditions (attached).

In the event that any of the recommended conditions are in conflict with other permits or licenses, the permittee shall adhere to the strictest of the applicable conditions. This location has been licensed as a restaurant since May 2003.

This matter was reviewed by Deputy City Attorney Amy Burton on January 5, 2011.

TIMING CONSIDERATIONS

The hearing date of February 1, 2011, has been posted on the business location, with the applicant and property owners within 300 feet notified by mail.

FISCAL IMPACT

The following fees were collected with the application: Building Review \$20 and Zoning Review \$15 (Development Services), Police Investigation \$1,159 (Police Department), and Labels \$90 (Financial Management Department).

The following fees will be collected if the application is approved: Business License \$320.70 and Regulatory \$977 (Financial Management Department).

Recommended Conditions of Operation

The Green Mango Inc., DBA Golden Villa Restaurant
1360 E Anaheim Street #205
Application for Entertainment with Dancing

In regards to the above named permit application for Entertainment with Dancing, the Department of Financial Management recommends approval subject to the following conditions:

CONDITIONS OF OPERATION

- The operation of the establishment shall be limited to those activities and elements expressly indicated on the permit application and approved by the City Council. Any change in the operation, which exceeds the conditions of the approved permit, will require that a new permit application be submitted to the City Council for their review and approval. {Issued per One-Year Short-Term permit dated 10/13/09; see condition #1}
- 2) Unless separately applied for, reviewed, and approved, no adult entertainment, as defined by section 5.72.115(B) LBMC shall be conducted on the permitted premises. {Issued per One-Year Short-Term permit dated 10/13/09; see condition #2}
- 3) Entertainment activities indicated on page #7 of your entertainment application shall be restricted between the hours of 10:00 a.m. and 11:00 p.m. Sunday through Thursday nights, and between 10:00 a.m. and 12:00 a.m. Friday and Saturday nights. {New}
- 4) Patrons under twenty-one (21) years of age shall not be permitted to enter nor to remain on the premises after the restaurant (food services) portion of the establishment has closed. Private functions not open to the public are exempt from this condition. {New}
- Due to the proximity of neighboring businesses and residences, all door(s) and windows shall be kept <u>closed at all times</u> during any musical entertainment, except in cases of emergency and to permit deliveries. Said door(s) is not to consist solely of a screen or ventilated security door. Sound shall not be audible beyond fifty feet (50') from the exterior of the premises in any direction. {New}
- 6) The permittee shall not hire promoters that advertise/promote or hold any entertainment activities consistent with nightclub entertainment. {Issued per One-Year Short-Term permit dated 10/13/09; see condition #12}
- 7) The permittee shall not allow employees to discard trash or beer bottles into the outside dumpster between the hours of 10 p.m. and 7 a.m. {Issued per One-Year Short-Term permit dated 10/13/09; see condition #6}

- During any entertainment activity listed on page #7 of the application, the permittee shall be responsible for maintaining an adequate security staff to supervise patrons inside the establishment and the parking lot. For crowds up to fifty (50) people, the permittee shall provide a minimum of one (1) security guard. For crowds over (50) fifty people, the permittee shall provide a minimum of one (1) additional security guard per fifty (50) people. Security guards must be identifiable as Golden Villa employees. Should the permittee's operations give rise to a substantial increase in complaints/calls for service, or trash left in the parking lot, the permittee shall increase staff, or employ uniformed licensed security guards, as directed by the Chief of Police. {Issued per One-Year Short-Term permit dated 10/13/09; see condition #7}
- 9) The permittee shall install and maintain a video surveillance system that monitors no less than the front and rear of the business with full view of the public right-of-ways and any parking lot under the control of the permittee. The video system must be capable of delineating on playback the activity and physical features of persona and areas within the premises. Recordings shall be retained for a minimum of 30 days and be accessible via the Internet by the Long Beach Police Department. A Public Internet Protocol (IP) address and user name/password is also required to allow the Long Beach Police Department to view live and recorded video from these cameras over the internet. All video security cameras shall be installed to the satisfaction of the Chief of Police, Director of Technology Services, and Director of Development Services. At the discretion of the Chief of Police, the permittee may be required to add additional video cameras. {New}
- The permittee shall take reasonable measures to prohibit and prevent the loitering of persons immediately outside any of the entrance/exit doors and the parking lot at all times. This should be done by use of security guards and/or signage indicating, words to the effect of, "Please respect our neighbors." {Issued per One-Year Short-Term permit dated 10/13/09; see condition #8}
- 11) Current occupancy loads shall be posted at all times, and the permittee shall have an effective system to keep count of the number of occupants present at any given time and provide that information to public safety personnel upon request. {Issued per One-Year Short-Term permit dated 10/13/09; see condition #10}
- Any graffiti painted or marked upon the premises, or on any adjacent area under the control of the licensee, shall be removed or painted over within 24 hours of being applied. {Issued per One-Year Short-Term permit dated 10/13/09; see condition #11}
- Golden Villa Restaurant, or agents, shall not distribute any advertising matter such as signs, posters, or promotional cards, in or upon any public property, or in or on any vehicle in any such place in the City. Distribution of any advertising matter upon private property shall adhere to the following guidelines: By placing the same matter in a receptacle, clip, or other device designed or intended to receive advertising matter. The permittee shall keep all agent contracts, including names, addresses and phone numbers, on file at all times, and must be available for inspection at anytime. {Issued per One-Year Short-Term permit dated 10/13/09; see condition #13}

14) This Entertainment Permit is accessory to the primary business, which is a restaurant. The authorization to provide entertainment on-site is subject to the use remaining as a restaurant, meaning a bona fide eating place serving actual and substantial meals.

"Meals" means the usual assortment of foods commonly ordered at various hours of the day; the service of such food only as sandwiches or salads shall not be deemed compliant with this requirement. Meals must consist of food prepared on the premises. Hours of sales of alcohol shall be limited to the hours when meals are available.

The premises must be equipped and maintained in good faith. The premises must possess working refrigeration, cooking equipment, utensils, menus, and enough food to make substantial meals.

In the event the primary business ceases operations, fails to operate as a bona fide eating place, fails to serve actual and substantial meals or otherwise fails to comply with this condition, the Entertainment Permit becomes null and void. {New}

- The permittee agrees to reimburse the City whenever excessive police services, as determined by the Chief of Police, are required as the result of any incident or nuisance arising out of or in connection with the permittee's operations. {Issued per One-Year Short-Term permit dated 10/13/09; see condition #15}
- The permittee shall maintain full compliance with all applicable laws, ABC laws, ordinances and stated conditions. In the event of a conflict with the requirements of this permit, the more stringent regulation shall apply. {Issued per One-Year Short-Term permit dated 10/13/09; see condition #16}
- The permittee, shall, within ninety (90) days of an approved entertainment permit, submit proof of attending the LEAD program offered by the Department of Alcoholic Beverage Control. In the event that the LEAD program class is not offered within this ninety day period, the permittee shall attend the next available class. Proof of completion shall be submitted to the Long Beach Police Department Vice Investigations Section. {Issued per One-Year Short-Term permit dated 10/13/09; see condition #17}







In response to your request for a recommendation regarding the above named permit application for Entertainment with Dancing, the Police Department recommends **approval** of a **One-Year Short-Term** permit, subject to the following seventeen (17) conditions of operation:

The Golden Villa Restaurant is located on the southeast corner of East Anaheim Street and Mahanna Avenue on the second floor of a small shopping center. The establishment serves an Asian food menu and is open for dinner. The business has been operating on a One-Year Short-Term Entertainment Permit because of previous condition violations.

Based upon the Vice Section's investigation, the Long Beach Police Department has found the public peace, safety, and welfare will not be impaired by the issuance of this permit, provided the appropriate conditions are imposed and observed by the applicant. During this investigation, Detectives determined the permittee was in violation of their ABC conditions by selling alcohol beyond their approved hours. Detectives have since spoken with the permittee regarding these violations, and have made undercover visits to confirm their compliance. The permittee has made improvements that have resulted in the reduction of calls-for-service and incidents. However, the Vice Investigations Section recommends a One-Year Short-Term Entertainment with Dancing permit would be in the best interests of the surrounding community and the City of Long Beach.

CONDITIONS OF OPERATION

- The operation of the establishment shall be limited to those activities and elements expressly indicated on the permit application and approved by the City Council. Any change in the operation, which exceeds the conditions of the approved permit, will require that a new permit application be submitted to the City Council for their review and approval.
- 2) Unless separately applied for, reviewed and approved, no adult entertainment, as defined by section 5.72.115(B) LBMC, shall be conducted on the permitted premises.
- 3) Entertainment activities indicated on page #7 of your entertainment application shall be restricted between the hours of 10:00 AM and 11 PM Sunday through Thursday nights, and between 10:00 AM and 12 Midnight Friday and Saturday nights.

- 4) Patrons under twenty-one (21) years of age shall not be permitted to enter nor to remain on the premises after the restaurant (food services) portion of the establishment has closed. Private functions not open to the public are exempt from this condition.
- Due to the proximity of neighboring businesses and residences, all door(s) and windows shall be kept <u>closed at all times</u> during any musical entertainment, except in cases of emergency and to permit deliveries. Said door(s) is not to consist solely of a screen or ventilated security door. Sound shall not be audible beyond fifty feet (50') from the exterior of the premises in any direction.
- The permittee shall not hire promoters that advertise/promote or hold any entertainment activities consistent with nightclub entertainment.
- 7) The permittee shall not allow employees to discard trash or beer bottles into the outside dumpster between the hours of 10 p.m. and 7 a.m.
- During any entertainment activity listed on page #7 of the application, the permittee shall be responsible for maintaining an adequate security staff to supervise patrons inside the establishment and the parking lot. For crowds up to fifty (50) people, the permittee shall provide a minimum of one (1) security guard. For crowds over (50) fifty people, the permittee shall provide a minimum of one (1) additional security guard per fifty (50) people. Security guards must be identifiable as Golden Villa employees. Should the permittee's operations give rise to a substantial increase in complaints/calls for service, or trash left in the parking lot, the permittee shall increase staff, or employ uniformed licensed security guards, as directed by the Chief of Police.
- 9) The permittee shall be responsible for installing and maintaining a video surveillance system that monitors no less than the front and rear of the business, with full view of the public right-of-ways and any parking lot under the control of the permittee. These cameras shall record video for a minimum of 30 days and be accessible via the Internet by the Long Beach Police Department. A Public Internet Protocol (IP) address and user name/password is also required to allow the Long Beach Police Department to view live and recorded video from these cameras over the Internet. All video security cameras shall be installed to the satisfaction of the Chief of Police, Director of Technology Services, and Director of Development Services. At the discretion of the Chief of Police, the permittee may be required to add additional video cameras

- The permittee shall take reasonable measures to prohibit and prevent the loitering of persons immediately outside any of the entrance/exit doors and the parking lot at all times. This should be done by use of security guards and/or signage indicating, words to the effect of, "Please respect our neighbors."
- 11) Current occupancy loads shall be posted at all times, and the permittee shall have an effective system to keep count of the number of occupants present at any given time, and provide that information to public safety personnel upon request.
- 12) Any graffiti painted or marked upon the premises, or on any adjacent area under the control of the licensee, shall be removed or painted over within 24 hours of being applied.
- 13) Golden Villa, or its agents, shall not distribute any advertising matter in or upon any public property, or in or on any vehicle in any such place in the City. Distribution of any advertising matter upon private property shall adhere to the following guidelines: By placing the same matter in a receptacle, clip, or other device designed or intended to receive advertising matter. The permittee shall keep all agent contracts, including names, addresses and phone numbers, on file at all times, and must be available for inspection at any time.
- 14) This Entertainment Permit is accessory to the primary business, which is a restaurant. The premises must possess working refrigeration, cooking equipment, utensils, menus, and enough food to make substantial meals. You must offer substantial sales of meals, during the normal meal hours that you are open. Fast food, snacks and hors d'oeuvres shall not constitute a substantial meal. Normal meal hours are: Breakfast 6:00 a.m. 9:00 a.m., Lunch 11:00 a.m. 2:00 p.m., and dinner 6:00 p.m. 9:00 p.m.

If you do not open by 6:00 p.m., you shall offer complete and substantial meals the entire time you are open for business, or for a minimum of three hours. In the event the primary business ceases operations or you fail to comply with this condition, your entertainment permit becomes null and void.

The permittee agrees to reimburse the City whenever excessive police services, as determined by the Chief of Police, are required as the result of any incident or nuisance arising out of, or in connection with the permittee's operations.
